

# A legacy born in the 1800s

The Tracy family has a history in the farming and cattle industry,

BUTTONWILLOW erations going back into the 1800s, beginning with William Tracy. Today, their family-held operations consist of the growing of cotton, wheat, potatoes, tomatoes, carrots, almonds and pistachios. Beef-raising rounds out the operations of the Buttonwillow Land & Cattle Company, a partnership made up of three families: the Freys, Selvedges and Tracys.

Tracy Ranch Inc. is a family-held corporation owned by widespread stockholders, also Freys, Selvidges and Tracys, including sons and daughters.

The family legacy began with Ferdinand Tracy (1829-1908) in the late 1850's in the gold mines near Kernville. However, the family uses the official birthdate of 1862 when Ferdinand and Wellington Canfield formed the partnership

Canfield & Tracy, a rangeland cattle operation. Their herds roamed the lower San Joaquin Valley, grazing on wild grass in an untamed dominion ruled by the likes of rattlesnakes, jackrabbits, coyotes and waterfowl, subject to the ruthless whims of the mighty Kern River.

In 1875 Ferdinand married Ellen Baker, the widow of Colonel Thomas Baker (deceased 1872). The marriage yielded two children, "Baby" and "Ferdie," who both died as infants.

# Traffic leads to big drug operation

A traffic stop led to an arrest of six people, the discovery of nearly 500 pounds of methamphetamine and the destruction of a drug lab in Shafter last Thursday.

California Highway Patrol officers initiated a SHAFTER

Shafter, CA

traffic stop on Wible Road in Bakersfield. The officers and a K9 Bart discovered about 97 pounds of methamphetamine inside the trunk of a Honda Accord being driven by Luis Cecena, 32, of Mexico City. This discovery led officers to conduct a search warrant at a suspect's home in Shafter. At a property in the 1700 block of Fresno Avenue, officers discovered a lab on the property that was suspected of manu-

The Kern County Sheriff's Office said in a statement

that this was a result of a lengthy investigation by a multiagency task force including the Kern County Rural Crimes Unit, Kern County High-Intensity Drug Trafficking Area Task Force Team and the California Highway Patrol. It is not clear what the cause behind the traffic stop was at the time.

At the residence, officers confiscated about 360 pounds of methamphetamine, 100 gallons of liquid meth, several

weapons and a substantial amount of cash.

Those taken into custody were Ronaldo Cain, 50, of Bakersfield; Luis Moreno-Andrade, 18, of Mexico City, Jose Aguirre-Chaidez, 22, of Sinaloa, Mexico, Felipe Angulo-Renteria, 36, of Mexico City, and Jose Violante-

Medina, 44, of Mexico City. Shafter Police Department's Assistant Chief Diana Burnett said that the arrest was a surprise to the department. "We didn't know anything about the situation until after the fact. Our Code Compliance officer was called out to assess the property and the integrity of the structure, which was deemed unsafe, and I believe Animal Control

was called out because of some fighting roosters." All of the suspects were booked into the Kern County Central Receiving Facility and are awaiting arraignment. The Sheriff's Office encourages anyone with information to call them at 661-861-3110.

That same year he bought a drive-in, Chuck Burger, that was popular and wellknown for his "Big C" burger. There, he

met the love of his life, Janice, when she came in to apply for a job and was hired. They went on to share 57 years of marriage.

He had a diverse professional background, working as a potato shed manager and correctional officer at San Luis Obispo. In McFarland, he and his father owned a small grocery store.

In 1978, Chuck sold Chuck Burger and started a career selling cars at Richland Chevrolet in Shafter. His friendliness and outgoing personality served him well in that role.





"We had a lot of trouble in Wasco. We had our store broken into twice in the time we were open there." One of the incidents caused the store owner to replace the majority of her inventory. "They took almost everything," commented Guardado. "We had to make the decision to close the Wasco store. I just didn't feel safe there."

When asked what she liked about Shafter, her first response was the people of Shafter and the feeling she has had when operating in Shafter. "I feel so much safer

here in Shafter. The Shafter Police Department has been so nice and have come so fast whenever we have had any problems." The store is run by her and her son and

daughter, a fully family-owned and operated business. Guardado said that she has always dreamed of owning her own candy store.

"I used to sell candies when I was a young child," said Guardado. "I was 13 when we moved to Shafter. I love this community and have always felt safe and appreciated here." Be it having some good candy, jumping

in an inflatable, or partying on down with a group of friends, Nancy Guardado is there to help out.

Guardado said that she gets her candies and the majority of her other supplies from Mexico and brings them back here to sell. Her collection of pinatas has something for everyone.

Guardado said that they also rent inflatables, tables, chairs - all things party-related. "The business has been great in Shafter and I just love the town. We get some business from online, but most of our business is the candies and pinatas we sell to the local people here. They are so great!"

Kern County has designated July as Purple Ribbon Month in memory of Kaitlyn and all the children who have lost their lives to preventable injuries in and around cars, and in order to educate and increase public awareness about the dangers of leaving children unattended in or around motor vehicles. There have been nine children who have died this year due to hyperthermia in the United

On July 18, the Kern County Board of Supervisors will proclaim July as Purple Ribbon Month. The purpose of the Purple Ribbon campaign is to remind the community that it only takes a few minutes for a car to heat up to temperatures that a young child's body cannot withstand.

There were 36 deaths of children last year alone that could have been prevented. You can follow the Purple Ribbon Month Campaign on social media platforms, @KernCountyDHS, the website www.kcdhs.org. All individuals are encouraged to play a role in making Kern County a safer place for children and

The campaign, according to the Kern County Public Health Department, has helped reduce deaths and injuries across Kern County. "It is so important to make residents aware that there is something we can do to prevent these injuries and

Students are required to purchase their

Host families learn about the culture of a new country from the student. "The students bring their culture. It

# Tracys build farm legacy

William Tracy, established what would be today's headquarters, the historical park on Wildwood Road, 5 miles northeast of Buttonwillow. This era was marked by the raising of Belgian draft horses and later ostriches. His marriage in 1904 to the daughter of another pioneer family, Fannie C. Rowlee, would yield six children, one of which succumbed to scarlet fever at age 8.

With the death of William Tracy on July 4, 1941, his widow, Fannie Tracy, rallied her widespread children and their spouses back to the ranch. The result was a turning point that saved a ranch ravaged by bad luck of the '20s and the Great Depression of the '30s. Fueled by the talents and resources of the Freys, Selvidges and Tracys, and made urgent by World

War II, the ranch was transformed from an equine focus into mechanized farming.

Today, in the 5th generation, diversity is their strength, the achievement of their unity and of all hearts in one place—the ranch.

Reaching its 140th year in 2002, the Tracy Ranch is joined today by only a handful of other surviving Kern County operations with roots going back to early California. They share one common beginning rangeland cattle. The family onerations even involved a flock of ostriches. In 1906, a female and male ostrich was shipped to the ranch for the purpose of gathering their plumages. By 1910, the flock was grown to 174 birds. A Tracy-owned company, Tracy Studio Design in Bakersfield,

was making robes, boas, pom-poms, fans and many other items. The birds eventually were shipped off; some were sold, others were donated to Hart Memorial Park.

Today, the company is run by generations of farmers from the three families. Michael Frey said, "We are a large family, but it takes each person to focus on a certain department of the operation. Currently, their biggest crops are almonds and pistachios. But, the family has also branched out into real estate, with ownership of a few office buildings in Bakersfield, as well as an oceanside hotel in Pismo Beach.

The one biggest challenge is the water. "With the federal regulations governing water and air quality, it is challenging. If we weren't already in farming, that would be a real barrier for entry."



### The tears of Jesus

the shortest verse in the Bible contains just two words: "Jesus wept." (John 11:35). There are several references in the Bible to Jesus crying or weeping.

graveside of a friend — a friend named Lazarus – whom Jesus was about to raise from the dead (John 11:1–44). This shows a Jesus accessible to human emotion, sharing the grief of others, experiencing the tragedy of death even as he was a conqueror over it. It's a helpful reminder to all believers in loss and grief that they

are not alone: our Lord also wept. There's another occasion when Jesus wept,

recorded in Luke 19:41-44. There, the setting was a lament over Jerusalem, who had not recognized the day of her visitation. In other words, this was deep grief over spiritual blindness and hard-heartedness, over a rejection of the very mercy that was so necessary. This is a grief that relates to Christ's work. For pastors, for everyone who cares about the triumphs of God's grace, there is a similar comfort here. You are not alone in mourning over the people who don't want grace, even though there is nothing they need more. Another instance is found, not in the

Gospels, but in the book of Hebrews. There we're told about Jesus that "He had offered up prayers and supplications, with vehement cries and tears to Him who was able to save Him from death, and was heard because of His godly fear. (Hebrews 5:7). The reference seems to be Christ's agony in Gethsemane, when he persisted in prayer and received strength to go through with the overwhelming horror of the crucifixion. The tears on that occasion let us know that when we weep for the difficulties coming upon us, we are not in the wrong. There can certainly be wrong attitudes, but a sinless Savior also cried out and shed tears as dreadful affliction reached him.

Finally, since the Psalms contain the language of Christ, the references to weeping there also relate to Jesus. Jesus used the

words of the Psalms as his own on many occasions, but very notably when he was being crucified (Psalm 22:1 and Matthew 27:46; Psalm 31:5 and Luke 23:46). He could use those words, because they were already his.

Thus Psalm 116:8 can be read in Christ's voice: For You have delivered my soul from death, my eyes from tears, and my feet from falling. These words tell us that in light of the resurrection of Christ, there will be an end to tears (Isaiah 25:8; Revelation 7:17). They are often appropriate now, but a day is coming when crying is at an end. We can know that, because that day has already dawned for Christ.
