## **Aquatics** gets OK

## \$141K to improve facility

The city of Shafter has received the goahead to begin their planned improvements to the Shafter Aquatic Center.

The Kern County Board of Supervisors voted to prove a release of funds and Environmental Clearance Certification for the community pool improvements.

According to city Public Works Director Michael James, the project provides funding for the renovat-

ing the facility at 269 Poso Ave. The property is owned by the City of Shafter, while the Shafter Recreation and Parks District manage its day-to-day operations.

Some of the work planned are the installation of Americans with Disability Act ac-

cess improvements, resurfacing of the concrete deck surrounding the pool area and pool replastering. James said that they are also planning to install a shade-providing

In addition, the existing grass will be demolished, and there will be landscaping improvements done, including grading and

site compaction. The project will be implemented with See AQUATICS Page 3

The Shafter Symphony will host the Synergy Chamber Players on Saturday evening at the Shafter Mennonite Brethren

The group of musicians say they love sharing the emotional experience of music by touching all of the audience's senses.

They believe that music is a synergistic expression of the emotional, physical, rational and spiritual aspects of the human experience, and that our musical traditions stand as one of the pinnacles of human achievement and endeavor. They seek to share musical works with California's Central Valley that they believe embody the best aspects of this and to connect musicians and audiences in a more direct and authentic way.

The group will be performing their "Evolution of Harmony" in Shafter on Saturday. This performance is an exploration of a broad landscape, filled with baroque music. Baroque is considered to be a challenging style of music that was made popular in the 1600s and 1700s that uses multiple keys and chords in one piece of music. There will be pieces by composers Sebastian Bach, Antonio Vivaldi and Henry Purcell, as well as Mandredini and Biber.

Most of the musicians in the Synergy Chamber Players are from Kern County. They formed to give the community a great musical experience. "We built a small chamber group and received some community support and have built an audience,"

said violinist Josh Estrada. The group has performed a variety of styles of music, including chamber music, baroque, classical, as well as more modern classical. This will be a very special opportunity to experience music from the baroque period, which is uncommon in our community.

## Generals outshined by North Stars, 27-13

The Shafter Generals dropped to 1-2 after a tough loss to Bakersfield's North High Stars 27-13, going below .500 for the first time in two years. The young Generals fought just as hard against themselves as they did against the Stars. Shafter had numerous mental mistakes and miscues, resulting in bad field po-

sition and stalled drives.

Sophomore terback Tyson Dozhier continued his struggles to lead the Generals to sustained drives. Dozhier ended the game 8-24 passing, throwing for 121 yards, the majority of them on a 52-yard touchdown play that started as a screen pass to Leo Fernandez, with Fernandez finding a path to the endzone. The Stars took a 7-0 lead on their first drive of the game. North made it 10-0 with a 32 yard field goal just four minutes later after a General turnover.

It was 10-7 after Jiet Sanchez's touchdown, getting the Generals right back in the game. But, the Stars extended the lead again when they connected on a long pass

play after Shafter had forced North into a third down and long situation. For the first time this year, the Generals defense was dominated on the line of scrimmage. The Stars managed three or four yards on average, the Generals never able to stop the Stars at the line of scrimmage. Shafter was unable to shore up the corners and were repeatedly beat on the outside as the Stars' running backs turned the corner on their sweeps for first downs and more.

The Stars also used the Generals' overeagerness at the line to occasionally run

right by the linemen as they rushed up the middle. Right before the half, the Stars tacked on a 34 yard field goal, making the halftime score 27-7.

The Shafter faithful were hopeful after the Generals narrowed the gap to 27-13 when they scored on a 6 yard touchdown pass from Dozhier to Joey Sanchez with 9:10 to go in the game. But, unlike the first

two weeks, the Generals defense was

unable to make a stand and get a stop. North seemed to be able to get just enough yards to keep the drives alive and eat up the time on the clock.

Shafter had a last-ditch effort with a few minutes left in the game but was unable to convert on a fourth down with four yards to go, giving the Stars the ball. North was able to run out the clock to end the game.

The Generals will hit the road on Friday night, traveling to Atascadero, trying to even the their record at 2-2.

Kern County with a capacity-building grant to allow them to increase the number of high schools where their program can help more girls succeed in school and go on to college.

■ We were similarly happy to provide funds to Teen Success to support their Kern County program working with teen mothers to assure they graduate from high school, not increase their family size and prepare for meaningful occupations or college. Both organizations are very successful, and we are thrilled to partner with them this year.

■ The first step in this competitive grant cycle is to submit a letter of intent through Kern Community Foundation's Online Grants Platform, which can be accessed at kernfoundation.org/grants, by 5 p.m. Friday, Nov.

Organizations interested in applying should have a 501(c) (3) nonprofit designation or fiscal sponsor. All organizations seeking funds must have a presence in Kern County and all programs must benefit women and/or

girls within Kern County. Funding is typically for one year only; and while multiyear grant requests may be considered, applicants should also be prepared to accept one

year's funding only. All requested followup reports for previous grants received from Kern Community Foundation, including The Women's and Girls' Fund, must be on file before an agency can apply for additional funding. Agencies must also comply with Kern Community Foundation's grant-making guidelines, which include:

■ Being registered with Kern Community Foundation through the same Online Grants Platform that can be accessed via the hyperlink above; and

■ Having a Silver or higher transparency rating on GuideStar.org, a database of nonprofits. Please refer to the "WGF's Grantmaking Policy and Focus Area Document"

Grantmaking) for more details. Following evaluation of LOIs by the WGF's Grants Allocation Committee, agencies will be invited in early December to submit full grant applications. The maximum individual award is \$25,000, and the total monies to be awarded are \$50,000.





## The rule that could change the world

"Do unto others as you would have them do unto vou."--The Golden Rule

"For you will be treated as you treat others. The standard you use in judging is the standard by which you will be judged." --Matthew 7:2 NLT

Ah, the golden rule -- remember that one. As kids, it was drilled into our heads and hearts by parents, teachers, clergy and the man on the street. Years ago, it was the mantra of business, church and government alike. However, through the years it has lost its luster, so to speak, and been replaced by the greed and self-centeredness of thoughts like "do unto to others before they have a chance to do it unto you." As the gold-chained strong man of the "A Team," Mr. T oft said, "I believe in the Golden Rule -- the man with the most gold, rules."

It does not matter whether you read the newspaper, turn on local and national news, or read the news feed on your IPhone, the news is the same. 
