At St. John's, a powerful re-creation of crucifixion

St. John the Evangelist Parish presented a moving reenactment of the Passion of Christ, a dramatic performance depicting the trial, suffering, crucifixion and death of Jesus Christ. There were elaborate costumes, music and set designs with dozens of actors that realistically portrayed the last hours of Jesus's life before his resurrection.

In an interview right before the play, Eulogio Arreola, sound technician and set designer, said, "We have been preparing since Lent started about 40 days ago. We've all participated for many years and were excited to perform again this year, which we have done year after year, nonstop, since 1998."

For those who attended, it was an extension of their faith and a way to celebrate Easter.

"I came to show my kids what Easter is all about, which is Jesus's death and resurrection to save us," Jenny Garcia said.





Stan Wilson gives lecture on POW camp

Shafter Depot Museum curator and local historian Stan Wilson gave an informative and entertaining lecture on the German POW camp that was stationed in Shafter back during World War II. Wilson was at the Shafter Library and Learning Center on Thursday evening and gave the attendees an informative recount of the prisoners who served as labor for the local cotton growers in the area beginning in 1944. He said local cotton growers were worried about a labor shortage on their farms, due to the number of people who were being involved in the war effort.

In 1943, the American government opened up several prisoner of war camps in California. Camp Cooke was the main camp in California, on the site of Vandenberg Air Force Base in Lompoc.

By late 1944, there were three POW camps set up in Kern County. Lamont had a camp that housed 900 prisoners, while Delano had 750 prisoners.

A third camp opened in Shafter in December 1944 at Shafter and Los Angeles avenues, the current site of the Sierra Vista Mobile Home Park. The prisoners stationed in Shafter were bused here from a camp in Idaho.

At the camp, 600 prisoners of war worked as a labor force for the local cotton growers. They lived in a series of barracks, each room housing six prisoners. The facility had a kitchen, an activity room, a common room and showers.

Each prisoner was paid 80 cents per day, which was put on their books in script that they could use at the camp's canteen. Once they were sent home, they could

WHS program encourages positive traits

Wasco High School has an incentive program designed to inspire student achievement called STRIPES. Focused on positive reinforcement, students are taking away the message of showing respect, doing the right thing, focusing in class and being involved on campus, among other things.

In its second year of the program, over 89% of the student body received at least one stripe of recognition from school leadership.

In September 2022, WHS rolled out the program to highlight positive student performance. STRIPES was created to reward students who excel in various categories of campus life. Administration wanted to encourage students in behaviors that will benefit them throughout their time at Wasco High and into their lives beyond high school. It has become a valuable component of the culture at Wasco High as students work hard to realize the







City advances plans for police department

At Tuesday night's Wasco City Council meeting, more progress was made toward developing the Wasco Police Department, including approval to execute all documents necessary to create a no-profit Police Activity League organization and authorization to finalize the purchase of additional police start-up vehicles.

Currently, the Kern County Sheriff's Department has a nonprofit Sheriff's Activity League located in a city-owned building at 1445 12th St. However, with their departure, the city must establish a nonprofit PAL organization specific to the WPD.

SAL and PAL programs offer a range of activities designed for the youth within a community. These programs foster a positive relationship between young people

and law enforcement officers while offering constructive activities during periods that may lack supervision.

City staff have secured grant funding for the refurbishment of the PAL building, and bids for the final rebuild phase of that project are being accepted. To create a new Wasco PAL entity, several steps are required, including the application for a 501(c)(3) tax ID, procuring insurance and getting approval of all relevant agencies.

"Once we are operational, I believe that the second biggest priority that I have is to reinstate youth programs through the PAL program. Our assistant city manager, Maria Lara, worked tirelessly to obtain grant funding for the refurbishing of what was the SAL building and will be working to upgrade the facility and provide youth

activities for the children of Wasco," WPD Police Chief Charles Fivecoat said.

In a staff report, Hurlbert said, "The Police Department project has moved forward at an accelerated pace and is expected to be fully operational in April 2024. To ensure all Police Department personnel are properly equipped at start-up, it is prudent to order the additional equipment now to avoid supply chain delays."

The council also approved purchasing three additional police cars for \$300,000, which is covered under the startup budget, according to City Manager Scott Hurlbert.

There was a new employee Police Department badge pinning ceremony for police officers Angel Sanchez and Larry Morris. Both have more than two decades of law enforcement experience. Morris comes from Delano department and Sanchez from Shafter.

"It's a good group of people," Morris said. "That's what brought me here."

Council approves development pact

The Shafter City Council Tuesday night approved a revised development agreement with Lennar Homes for the Marcona Preserve development off of Seventh Standard Road. This property would be the site of 395 residential lots, ranging in size from 5,508 square feet to 23,345 square feet (a large corner lot). The minimum size of a residential unit is 1,400 square feet.

The agreement includes environmen-

tal impact fees of up to \$15,000. This agreement will eliminate any uncertainty and provide for the orderly development of the property. It also is intended to ensure progressive installation of necessary improvements and provide public services for the development.

During the Public Comment portion of the meeting, several business owners voiced concerns about limited parking in downtown Shafter. Amanda Kirschen-

mann, owner of Sun Country Flowers on Central Avenue, said that the parking spaces in front of her store have been occupied every day by the same five cars, forcing her customers to park farther from the store than they should have to. "I have received calls from customers telling me that they were sorry but they didn't stop because there was no place to park by her store."

Another business owner, Giselle Hernandez of The Hub, voiced a similar concern about the lack of parking. "I have customers that cannot walk very far, and they

won't stop if they see no available parking near my business."

In a brainstorming session of the business owners, they thought of a possibility of maybe getting the city to assign certain parking spaces right in front of businesses, as designated for that business, or even making the spaces right in front of businesses restricted to 15 or 20 minutes, punishable by citations if not followed.

The council said that they would take these concerns under advisement and discuss the matter.

Shafter Police welcomes two new officers

A ceremony was held at Bakersfield High School in which 32 trainees received their badges in a pinning ceremony after the trainees completed an extensive training program.

Of the 32 graduates, two of those were to become new members of the Shafter Police Department.

Officer Herrera was pinned by Acting Chief Randy Milligan, as was Officer Escutia. They were among 47 trainees that started the program over six months ago that were sworn in by Judge David Zulfa. The officers also were welcomed by Shafter Mayor Chad Givens, Mayor Pro-Tem Cathy Prout and Councilmember Pete Espinoza.

Herrera and Escutia went through 960 hours of training. It included weapons and chemical agent instruction, report writing,

crisis intervention and physical fitness.

"The training was very challenging, but we endured and are ready to serve our community."

According to Acting Chief Milligan, both officers left professional careers to pursue a career in law enforcement. "We sponsored them through the academy. They are not from Shafter but are from a nearby city."

The graduation started with a video about the training academy for the class of 2023-28, followed by the ceremonial flag presentation and the national anthem.

Kern County Sheriff Donny Youngblood reminded the officers that joining law enforcement is a great privilege, but also a great responsibility.

"You have an enormous amount of responsibility and authority. Never, ever abuse that, because your integrity is all you

have in this line of work," Youngblood said. It is not known at this time where the new officers will be stationed, or their du-

ties. The department is in the process of preparing the substation in the Gossamer Grove area for an opening later this year.

S - Show respect. Following directions the first time, doing the right thing, respecting others/property.

T - Technologically responsible. Bringing charger and charged Chromebook to class, following cell phone policy.

R - Ready for college and career. Visiting the Career Center, focusing in class, meeting with counselor.

I - Involved on campus. Joining a club or sport, making rally posters, participating in dress-up days,

P - Prompt and present. Being seated and ready to work when the bell rings, having no tardies,

E - Engaged learner. Coming prepared with all needed materials, asking questions, participating in class.

S - Service minded. Throwing away trash, leaving classroom clean, helping others, opening doors.

Faculty, teachers and staff present students with STRIPES. tickets when they are recognized for meeting at least one of the criteria. Students are then entered into a weekly drawing.



Braun was presented the award at the


66th Annual Conference of the California Association of Public Cemeteries in San Diego on March 16.

- (1) A proposed special assessment of **\$105** upon each acre of developed land within the District and a proposed special assessment of **\$6** upon each acre of undeveloped land within the District shall be levied in order to meet the District's estimated obligations during the year 2024 as reflected in the District's Annual Estimate of Obligations being filed with the Clerk of the Board of Supervisors of the County of Kern and in order to cause just and equitable sharing among District's landowners of District's obligations and in said budget heretofore adopted.
- (2) A public hearing on said proposed special assessment shall be held at 9:15 A.M. on April 11, 2024 at the office of the District located at 17207 Industrial Farm Road, Bakersfield, CA 93308.
- (3) This resolution shall be publicly published pursuant to Section 6066 of the Government Code of the State of California in The Shafter Press and a copy shall be mailed first-class, postage prepaid, to each holder of title to land within the District as shown by the District's current assessment roll.

turn the script in for a check. The facility was surrounded by barbed wire and was monitored by guards stationed in guard towers on the site. When the project began, a goal was set for each prisoner to pick 150 pounds of cotton per day. The first month, the productivity was only at about 50 pounds per day. Also, the prisoners were forced to work to get their wage and food. If they chose not to work that day, they would not be given anything to eat for the day. After a month, the leaders of the prisoners' group organized a strike. As a result, the prisoners were fed only bread and water for several days. To deter the revolt, the outspoken prisoners who were against the guards and administration were transported to different camps. According to Wilson, the majority of the camp prisoners were just men grateful for not being on the front lines and being treated as decently as they had ever been

since the war started. There were even friendships that were fostered during this time. Wilson said that his grandfather struck up a friendship with one of the prisoners that would go to his farm and pick cotton. Even after the soldier was sent back home, Wilson's grandfather received letters and gifts from Germany from his friend, Joe Durscht. Wilson said that his grandparents even made a trip to Germany many years later and met Durscht and his family. Wilson said that even though they were the enemy, the men for the most part were cooperative and contributed to the local economy with their hard work. In 1946, the camp was closed, and it was uncertain what would be done with the facility. For a time, it was operated as a farm labor camp housing hundreds of local farm laborers and their families. In 1955, the site was demolished. Wilson will be presenting another lecture on Thursday April 11, at the Shafter

It was an Evening with the Mustangs at Teresa Burke Elementary School for families to hear about the things happening in the Wasco Union Elementary School District. Assistant Superintendent Oscar Luna presented the Local Control Accountability Plan for them to provide feedback and input.

The Local Control Accountability Plan is the district's three-year guide for how it will use state Local Control Funding Formula funding to service all students.

The LCFF is California's formula for determining the level of state funding provided to school districts. The majority of funding is dedicated to improving academic outcomes for all students, with additional funding provided for English learners, foster youth and students living in poverty.

Luna said about his presentation, "I like to explain it in a simple manner and hear your feedback." He then shared a district

overview highlighting key statistics showing there are 3,500 students (TK through 8th) in the WUESD, 95% are Hispanic, 93% are low-income, 36% are English learners, 580 employees, four elementary schools, two middle schools and one independent studies.

He said of the district's funding, "We have to detail how we are going to spend that money. We have \$14 million this year [to be used for concentrated and supplemental funding, which can only go to low-income, English language learners, homeless or foster students. That's why we are here, so you can give us suggestions on how we can spend that money."

Belinda Martinez is a 5th-grade teacher, "Tonight is important because it gives the parents an opportunity to know what is happening at the school, learn about the different programs and gives them a chance to ask questions."

Parent Jesus Cordova said he attended

to support his son and daughter. "I want to keep updated on how the school is operating for them and to see their future plans

for their education."

Another parent, Alejandro Alvarez, added, "I'm here because I care about my children's future and want the best for them. I hope that with tonight's information, I will better understand the direction in which the district is headed with their education."

It was a festive event with a chicken dinner prepared by Principal Ellis, performances by the Wasco Bengal cheerleaders, raffle prizes and folkloric dancing by the Teresa Burke after-school dance club.

Dr. Ellis said the event served as an opportunity to forge closer ties with those involved. "It drives relationships and stronger component of understanding. When relationships are established, you build stronger lines of communication and this only helps to drive more meaningful and impactful input/feedback."

Luna ended the evening by thanking the parents. "We value your opinion." In a statement afterward, he said, "Their input influences our plans, goals and initiatives."

This is never a productive practice, but He waits patiently, ready to plug us back in when we are ready to receive that power once again. "We can do all things through Christ, with his power, using His gifts that he bestows upon us to help us use His mighty power," he said in his message.

Toews led the hymn "Because He Lives" before those assembled were dismissed with a closing prayer by Craig Haley.

This service drew people from a variety of sources and different denominations, coming together for a common purpose.
