Couch winning re-election, Garvey in lead

David Couch appears to be headed to another term as in his race for re-election, according to the Kern County Elections office, with results as of early Wednesday morning.

In the race for supervisor of the 4th DisSHAFTER | WASCO

trict, Couch has amassed a big lead, with 52% of the vote, enough to return him to office without a runoff.

Candidate Veronica Cruz Vasquez has received a little over 17% of the vote, with Wasco Mayor Alex Garcia with 16% and Salvador Solorio-Ruiz with 14%.

If the percentages hold, Couch would be declared the winner of the seat, with no runoff taking place in November. If a candidate gets more than 50% of the See COUCH Page 7



While the Shafter High girls wrestling team has had unprecedented success this year, their feeder program has also shined this season. The Shafter Youth Wrestling team, the Shafter Spartans, has a young wrestler that is on his way to the State Tournament at Selland Arena in Fresno this weekend.

Nehamiah Salcido, who is in just his third year of competitive wrestling, will be competing in the 2nd/3rd division in the 77 lbs. weight class. Salcido has already captured a Valley title and a Masters title on his way to the State tourney. Coached by SHS girls Coach Eli Espericueta, he has

climbed the ladder to this success with determination and hard work.

Salcido is in his third year of wrestling after joining a local wrestling camp - Solid Stone at the Mennonite Brethren Church run by Pastor Pat Coyle and Coach Espericueta. He found a passion throughout his first season and ended up making it to Selland Arena, placing 5th at the State Championship in his weight bracket.

In his second year of wrestling, he placed top three in multiple tournaments and made it to Reno Worlds Championship, with over 2,500 wrestlers from all over the country making it to the quarterfinals. This year he goes into the 2/3rd grade

77 lb. weight class, having placed 1st in the Valley Championship at Wasco and 1st at Masters in Tulare. Nehemiah's parents, Rocky and Amber Salcido, are excited to cheer him on again this weekend.

He is number 3 out of 4 in the Salcido household. He carries on the tradition of Valley Champion and State qualifier, since his older brother is also a Valley champ and State runner up with the 2022/2023 Shafter High football team. The Shafter City Council listened to the annual financial report for the fiscal year of 2023 at its

day night.

SHAFTER meeting Tues-

Christian Townes, CPA partner with LSL, Inc., gave a report on their audit of the city finances. Townes said that the company performed detailed testing of account balances and transactions. The

results of the audit said that the city's financial statements were accurate and reliable for the year ending June 30, 2023.

They identified no fraud, waste or abuse during the fiscal year.

One financial highlight of the year was an increase in the city's net position of \$8.8 million, bringing the total to

\$216.7 million.

Capital assets for the city increased by \$4 million, with the city stable in its financial position, with a high level of credit worthiness and one of the most financially strong cities in the county.

The council unanimously to accept the report.

In other action, the

council approved a \$90,000 contract with Ordiz-Melby Architects, Inc. for the design of the new Aquatic Center modular building to replace the existing building. It will include restrooms, a concession stand, lockers and offices.

The council also approved a \$50,000 contract with Kroeker, Inc. for the demolition of the existing Aquatic Center build-


The Shafter DYW program is one of the oldest in the state and has helped many



Couch has faced a challenge ever since the district's boundary lines were redrawn a few years ago. This adjustment made the district more Democratic on the map, with the exclusion of the cities of Taft and Maricopa.

One voter, a Shafter resident who wished to remain anonymous, said that she thought this was going to happen. Ve-

ronica Managan said, "I was afraid that the Democrats in the race would split the vote so much that there would be a chance that Couch would get 50%. If it stays like this, we just shot ourselves in the foot." Another resident, who voted for

Couch, said, "I was hoping that this would happen. With no opposition, I knew that he would probably get the 50% he needs to get elected," said Vincent Sanchez. " I think that Couch is the best person for the

job, and he will keep representing us and listening to our concerns."

In the 22nd Congressional District race, there is going to definitely be a runoff in November, with Democrat Rudy Salas having a slim lead over Republican David Valadao on Wednesday, with Salas getting 35% and Valadao receiving 32%.

In the national race, Donald Trump and Joe Biden won their primaries handily, with strong showings in Kern County. Trump won 84.8% of the GOP county vote, and Briden took 85% of the Democrats in the early count.

Although Democratic Congressman Adam Schiff came out the winner in the state, GOP hopeful Steve Garvey, the former Dodger and Padre, was the big leader in the county, 48.6% to 28.3%. They will go up against each other in the November runoff for the Senate seat vacated by Diane
