# Richland improves in English and math

The Richland School District is on track with their budget so far this year, according to the LCAP report that tracks educational and financial goals.

The district's Board of Trustees received the midyear report Tuesday night, The budgetary evaluation was "satisfactory," with the only difference from the budget and the actual spending so far is the money which was used as part of the emergency covid funding that every district received.

On the educational front, the district is hitting a lot of its goals, including decreasing the gap in the standards for English and math when compared to the goals and standards set by the state. Assistant Superintendent Annette Blacklock said that the district has been working hard to meet or exceed its goals and been successful in many of their endeavors.

They also saw the district meet or exceed their goals for special education students. Over 50% of special education students participate in a regular classroom environment at least 80% of the school day.

One area still on the decline in the district is the amount of chronic absenteeism. At the beginning of the cycle, the rate was at 11%. The district set a goal to decrease that number by 5%. The opposite happened, with absenteeism almost doubling to 21%.

In other action, the board approved a field trip for special education students to the campus of Fresno State University, where they will attend workshops and also get to attend a sporting event.

The board also voted to give a notice to

PINCO, the Partners in Nutrition Cooperative, which the district uses for their food supply needs for their menus. Financial Director Martin Rodriguez told the board that the cooperative has been inconsistent with fulfilling their orders, have not been timely in their deliveries and have not lived up to the agreement and standards set by the board and the district. Rodriguez said that the board would be better served to go with a different cooperative, and the selection process could begin immediately. The vote was unanimous. This would affect the district beginning in the 2025-26 school year.

The City of Wasco has been awarded the prestigious Annual Comprehensive Financial Report award for 2022. This achievement marks a significant milestone for the city, since it was last recognized in 2012.

Over the years, we've faced challenges such as frequent staffing shortages and frequent leadership turnover within the Finance Department, making this achievement even more remarkable," Finance Director Isarel Perez-Hernandez said.

"However, through perseverance and teamwork, we have once again secured this highly coveted award from the Government Finance Officers Association. A certificate is awarded only if there is consensus among reviewers that an annual comprehensive financial report substantially complies with both Generally Accepted Accounting Principles and program policy."

The award was based on the accuracy and completeness of financial statements, compliance with legal and regulatory requirements, demonstration of fiscal responsibility and accountability, timeliness in preparing and submitting financial reports, use of best practices in financial management and reporting, adequate disclosure of financial information, presentation of financial information in a clear and understandable manner, overall quality and professionalism of financial reporting, use of technology to enhance financial reporting processes, incorporation of forward-looking financial projections or analyses, evidence of continuous improvements in financial reporting **See CITY Page 8** 

# Wasco mayor wants to represent rural areas

First in a series of interviews with candidates for Kern County supervisor in the 4th District, including the Shafter and Wasco areas.

Alex Garcia was born and raised in Wasco. He attended Fresno State University and graduated with a bachelor's degree in political science. Garcia moved back to Kern County in 2015 to work for Assemblyman Rudy Salas as a field representative for Arvin, Lamont, Wasco and Shafter.

"I built good relationships in those communities that I still maintain today," he said.

#### THE RACE FOR COUNTY SUPERVISOR

In 2016, he left the Assembly and ran for City Council. "This will be my eighth year serving my third term as city mayor. During my time, we've done many outside-the-box activities."

These would include "Mondays with the Mayor," an open-door office hours, which he is bringing back this year, "for people to share their concerns and complaints with the mayor. And in alignment with building healthy communities, we also introduced 'Mayors and Moms,' a short series introduced during the pandemic. We did Zumba in the park and a number of neighborhood community meetings. All of this, to the labor camp clean up and helping to start the brand new police department."

He said that Kern County is facing many challenges. "But primary among them is selecting the next chief administrative officer, in addition to resolving the recruitment and retainment crisis our county faces from public safety and other public workers."

He also sees the importance of careful funding distribution, including "equitable allocation of the new Measure K dollars to our rural outlying communities and investing and protecting our public spaces is my third priority. For too long, our See WASCO Page 8



# WRPD keeps kids active with sports

Recreation and WASCO Parks District,

with registration now open.

"Wasco Little League Baseball is open to boys ages 7-12 who reside or attend any schools within our boundaries," WRPD Manager Chris Serna said.

It is a live-pitch baseball program. "This is a competitive division with rules and uidelines associated with Little Leag International. There is a Majors and Minors Division offered." The Majors Division offers a higher, more competitive level of play than the Minors Division. Players must be League age 10-12 to be eligible for Majors. "A draft is conducted to fill the available slots on our Majors teams. Players not selected to play in the Majors Division will be placed in the Minors draft." "There are advantages and disadvantages to participating in Majors. The most obvious advantage is the chance to play at



All registrants must attend one assessment to play in this league and be drafted by coaches. Tentative assessments are scheduled for Monday and Tuesday, Feb. 26 and 27. The season runs from April through May. Registration is \$70, and the deadline is Sunday, Feb. 25.

The Coach Pitch Program is designed for ages 5-6 years old. "Coaches will pitch to their own team. This program focuses on the fundamentals of baseball and is designed to build a solid foundation for becoming a successful ballplayer. Coaches are allowed on the field to assist athletes during the game. This is a noncompeti-tive league." The season runs from April through May. Registration is \$65, and the deadline is Sunday, March 3.

#### The 2023 Little League All Star baseball team

a higher level of competition, often against (and with) the best players in our community. However, parents should also know that the participation rules are slightly different for Majors than for Minors.'

All registrants must attend one assessment to play in this league and be drafted by coaches. Assessments are scheduled for Monday and Tuesday, March 4 and 5. The season runs from March through June, with the Little League registration costing \$110 and a deadline of March 3.

The Minter Field site was dedicated in February 1942 as the Minter Field Army Air Corps Base, in honor of local man Hugh Minter.

Minter Field was originally constructed under the Defense Landing Area Program for the U.S. Army as a flight training center. It was a city within itself, having served the 7,000 personnel stationed at the airfield during World War II for training, living and recreational needs. Although many of the facilities have been removed over the years, there was a chapel, swimming pool, theater, post office and infirmary, among just a few of the services that were provided for those stationed here.

The remaining buildings are now used as offices or warehouses, including the airport administration office.

Today, the site still has a variety of hangars, warehouses, offices and the Minter Field Air Museum. The museum houses thousands of articles of history from every U.S. military conflict. The museum is open every Friday and Saturday from 10 a.m. to 2 p.m.. They can also give group tours by appointment. Their telephone ist 661-393-0291.

The camaraderie between the swimmers is something that the coaches encourage. "One of the things that we do, and this is a long-standing tradition even before Chris started coaching the team, the families come together and prepare a pasta dinner for the swimmers the night before each meet. We eat together, hang out, talk about their goals and it's team building and bonding," Melody said.

In the short term, Chris

said his goals are "to get the new swimmers to look like they have been swimming for years." His long-term goal is "to continue to build the team, and hopefully, with each year, we can send more of these kids to the Valley Championship."

Residents will have a chance to dispose of items that are not accepted with regular trash collection. Examples are batteries, mo-

Residents must label all containers, make sure the containers are not leaking and cannot mix wastes into the same container. There is to be no more than 15 gallons or 125 pounds of waste per trip to be accepted.

customers only. Business waste will not be accepted.

In an effort to keep the streets, alleyways and land in the Shafter area free of debris, events such as this are being held to help residents dispose of hazardous materials legally and safely.



regional parks have lacked the investment and maintenance district four families deserve. Did you know that Kern County doesn't have a park and recreational department? I will make it my priority to advocate for the establishment of a master plan maintenance budget for each of our county parks. In addition to hiring a bonafide parks and recreation director."

He believes he is the most qualified candidate. "In 2022, voters passed term limits for our county supervisors, and if that is not a mandate for change, then I

don't know what is. District 4 deserves a supervisor reflective of our communities - a voice for our majority rural families. Our small towns and unincorporated areas have gone without adequate resources and support from our county government for too long. I will be a champion for rural Kern. District 4 families should not have to wait eight more years for the change they deserve."

Regarding the most pressing issues, he said, "From my conversations with business leaders and industry in Kern, what we lack most to attract growth and new

jobs in our region would be a fully skilled workforce. As we transition into the jobs of the 21st century, we need to work with our partners at the Kern Community College District and our brothers and sisters in labor to bolster vocational training and apprenticeship programs. Ensuring a pool of higher skilled workers will equal higher paying jobs, which is good for everybody's household economies."

He said he has the leadership qualities a supervisor should have, "For one, I am not a career politician. My greatest asset is my heart. I need no title or position to serve my

community. I am passionate about my public service. My accomplishments and lessons learned in my decade as a community leader make me the best candidate for the job."

For his long-term vision, he said there are brighter days ahead when there is teamwork. "In this day and age, voters aren't looking for perfect community leaders; they are looking for public servants that can work across the aisle with everyone to achieve our shared goals. I have a record of doing just that on the Wasco City Council, the Kern Council of Governments and the Kern Health Systems board."




