# Council approves library committee

The City Council approved forming an adhoc committee that would explore ways to keep the library open.

The library is currently open two days a week until June.

The City of Shafter came to an agreement

last month to cover the costs for the operation of the library for a short-term period.

The committee will be led by Mayor Pro-Tem Chad Givens and council member Gilbert Alvarado and will include other community members.


Shafter High Coach Jerald Pierucci also gave a presentation to the council that highlighted the planned video scoreboard that will be a part of the new stadium renovation.

The scoreboard will be 24.5 feet by 10 feet and will include a video board that can show instant replay, slow motion, as well as different graphics that would be prepared at the Media Lab at the high school.

This board would be used for football, soccer, track, the Fourth of July fireworks show and Shafter High and Richland Junior High graduation ceremonies. The board would be able to show graduates walking across the stage on the big screen.

# City manager: High Speed Rail 'ignored' residents

The High Speed Rail Authority continues to be an ongoing problem for the **WASCO** city.

"The reality is, Wasco was a small fish and was ignored," City Manager Daniel Ortiz-Hernandez said. "The city opposed it every step of the way."

Ortiz-Hernandez gave a presentation to the City Council from the city's perspective of the problems associated with the HSR Authority. A map of the originally proposed railroad track alongside the alternative HSR tracks was enclosed in the April 6 City Council meeting packet.

Ortiz-Hernandez explained at See CITY Page 4

# Kern County moves into orange tier

The state of the pandemic in Kern County is moving in the right direction as the county entered the orange tier **REGIONAL** Everyone is requested to

continue wearing masks and maintaining safe social distancing, Director of Public Health Michelle Corson said. The state also announced that a total of 4 million vaccine doses have been administered to people living in the

lowest quartile of the state and because of that, the state has a new case-rate threshold within the Blueprint Tier Framework. In addition, in a televised broadcast held by Gov. Gavin Newsom on Tuesday, April 6, Newsom said the state will be doing away with the four-tier system June 15 and the state

should be able to resume most of the pre-pandemic activities within reason. This move to the orange tier means that businesses may now have 50% occupancy and indoor dining changes to

50% occupancy as well. The orange tier also means that there are fewer restrictions and increased capacity on some businesses such as fitness centers and restaurants. Counties that reach the orange tier could also see the opening of bowling alleys, bars

'Office workers are encouraged to continue teleworking but opening indoor with restrictions is allowed," Corson

Superintendent of the Wasco Union Elementary School District Kelly Richers said that eighth graders will return to the classrooms May 24 and the district will hold in-person graduations on May 27.

At the time of this story, the Wasco Union High School District has not replied for comment.

For Tuesday, April 6, Wasco had 5,350 infected, 2,175 covered and 2.699 assumed recovered. These numbers compared to those of March 30 of infected at 5,317.

For the same period in Shafter, the number of infected was 3,506, with a comparison of 3,494 infected the week of March 31. There were also 1,372 recovered on April 6 and 2,015 presumed recovered.

## Landmark hotel vandalized

According to Shafter Historical Society President Roy Shaffner, vandals kicked part of the fence in and gained access to the property. They then broke several windows and the front door with what is believed to

Hurlbert said that they are working with the Shafter Police Department to establish a reward for information that leads to the identification and conviction of those responsible for the damage.

"We are canvassing the area and will follow up on any information that we get to identify those responsible," Burnett

The Green Hotel was constructed in 1913 by the Kern County Land Company to house prospective land buyers. Located centrally downtown at the corner of James and Central, it was the city's first commercial building. The recent work on James Street has improved the sidewalk in front of the hotel.





# Cemetery district manager to retire

Tim Unruh, who has served Kern County and specifically the areas around Shafter and Wasco, as the district manager of the Kern Cemetery District, is retiring at the end of this week.



Tim Unruh and the district received an award from the State Assembly.

Unruh has held this position for over 34 years, beginning his tenure in January 1978. During his years in the district, Unruh has been instrumental in ushering in the "computer age," developing the district's first database.

Another strong point for Unruh, according to his District Secretary Eliza Caudillo, is the leadership that Unruh has shown throughout the years. "Tim has managed both the Shafter and

Wasco cemeteries with kindness and compassion. He has always worked hard to keep things in order and cared for the employees and their families professionally and efficiently," said Caudillo. Unruh was awarded a proclamation

from the Kern Cemetery District upon his retirement in which they said that Unruh has been "sensitive to the district's needs and hired an incredible team of employees," notably Caudillo and Superintendent Denny Carender.

The district also said that Unruh recognized the need within the communities to accommodate for a resting place for their loved ones's remains and facilitated the installation of niche walls at both cemeteries.

Unruh helped double the cemetery acreage in 1998. During his tenure, both cemeteries also created Veteran Memorial Walls, in which the names of the veterans buried in the cemeteries are etched into the walls. The Kern Cemetery District has been

awarded the District of Distinction award by the California Special Districts Association, as well as the District Transparency Certificate. Unruh also receive numerous awards

from the California Association of Public Cemeteries. Among the awards are being named on the Board of Directors from 2003 – 2019, as well as being awarded the Cemetarian of the Year in 2001. Unruh also received the Siemens-Byington Memorial

The company that will be building the board is Daktronics, who has created boards for a variety of college and professional sports stadiums throughout the country.

"We would be the only school in the Central Valley that would have one of these boards and its capabilities, which would be

great for our kids and our entire community," said Pierucci. The board would also help local busi-

nesses who could buy space on the board for advertising, giving the companies a wide audience on a weekly basis. The cost of the video scoreboard is

around \$196,000. It will also have a state-

of-the-art sound system that would cover the entire stadium, the field as well as the stands area. When asked about the sound concerns that residents may have, Pierucci said that he and Principal Russell Shipley decided to flip the sides of the field that the scoreboard had previously been on. The new scoreboard would be facing away from

the street, which will lessen the sound that would reach the residential areas, as well as the video graphics on the screen.

The operations of the scoreboard and graphics would be done by Shafter High students who would become certified to operate the software and programs provided by Daktronics.

# Council: HSR 'not living up to policy'

the time the state voted to approve the HSR in 2008, the HSR Authority was unable to provide a completed set of design plans when the project was presented to the voters and continues to add and change the project as it moves along the Central Val-

One of Ortiz-Hernandez's issues was that one of the proposed tracks went through an unpopulated portion of Wasco while the other track ran right through the most-populated portion of the city. The HSR chose the most-populated portion of the city to run the track.

In 2011, the City of Wasco passed Resolution #2796, supporting the development of the HSR alignment along the east side of the existing rail alignment because it would have less of an impact on the community.

In 2012, Resolution #2836 opposed the HSR project as its proposed alignment went through the city and would have negative impacts to the community because the proposed alignments would damage "significant amounts of local residences, businesses, historical structures, culturally significant structures, open spaces and other basic critical infrastructure."

In 2015, the City Council passed Resolution #3073 opposing the HSR project as proposed and requested less-damaging al-

The Amtrak station, which was built in 2006, is considered one of the major Amtrak lines in California — Capitol Corridor, San Juaquin and Surf liner are among three of the five busiest. Once the HSR begins service, Amtrak will no longer stop in Wasco and riders will have to travel to Bakersfield to catch the train.

Also, the state has said that it cannot fund two rail services once the HSR goes online. Therefore the Amtrak station was

"It only took one day for the HSR to demolish the Amtrak station," Ortiz-Hernan-Relocating the former farm labor hous-

ing residents was in lieu of building a concrete sound wall, which would have created noise as well as loud vibrations, Ortiz-Hernandez explained.

In 2014, the HSR Authority approved

the Final Environmental Impact Report/ Environmental Impact Statement for the Fresno to Bakersfield section of the HSR.

The EIR/EIS states within the mitigation document that the identified affordable housing development located east of the rail lines on J and 6th Street was an environmental justice community requiring

The proposed mitigation was the Wasco Farm Labor Farmworkers Housing Relocation Project, which will build and relocate the community at that time.

The Wasco Farmworker Housing Development project was underway before the HSR project began. The original design included a sound wall between the housing complex and the freight train. In 2018, the HSR provided \$10 million for the new housing project that was completed in In May 2016, former Mayor Cheryl We-

gman and former City Manager Paul Paris addressed the HSR Board of Directors regarding the proposed mitigation agreement.

"The HSR is a detriment to our community," Ortiz-Hernandez said. "The HSR was considering two different paths. Wasco is directly in the path of the HSR. The HSR knew which path it was going to take and could have chosen to bypass Wasco. When the plan was proposed to the City Council back then, the City Council was opposed to the project."

The council members were in agreement about the HSR not living up to its policy statement of no negative impact on any community where the HSR was being constructed. The council members also agreed that the HSR should pay for the demolition of the former farm labor housing.

In addition to the issues raised in Wasco, city officials in Tehachapi are raising concerns such as the track running through the city without making a stop.

The HSR officials stated that the City of Tehachapi complaints were presented in writing to the HSR last spring.

"The Authority is working on these matters on mitigation measures as part of the environmental process," California Regional Director LaDonna DiCamillo said. "The HSR is reviewing Tehachapi's concerns and are hopeful a solution can be reached."

Students can earn an Associate of Science degree in either AG Business or Ag Mechanics through the program while earning their high school di-

"Many of the classes are regular college prep classes," Wonderful Agriculture Career Prep Coordinator for Wasco High David Abernathy said. "In several subjects such as English, math, science and history, students receive high school credit but also college credit for that same class if it is a General Education requirement. Students will graduate with 20 units of college credit."

Abernathy said that the Ag Mechanics degree incorporates the machinery used in the agriculture side of the program and the Ag Business classes incorporate the business side

of agriculture. "Students will have attained 60 units of college credit when they graduate from high school. If a student is on track, there are two electives available each semester including the

summer to take the classes," Abernathy added. "If a student gets a failing grade in one of the general education classes, that class must be repeated."

"The program pays for all the books materials," Abernathy said. "The program is zero cost to students." The Wonderful schedule also al-

lows students to participate in all sports, leadership and extracurricular

In 2020, Abernathy said that there

were 150 applicants for the program, but the program has room for only 70

Accepted program students will have access to college visitation trips all four years including such colleges as UC Davis, Cal Poly Pomona, Cal Poly San Luis Obispo and Fresno State. There is also job shadowing experience for sophomore and junior years and a paid internship senior year during the summer semester.



# The Paneros brought Hollywood to Shafter

This article by Shafter resident Dolly Hei originally appeared in the Shafter Historical Society's newsletter, Spring 2015.

From the late 1930s into the '60s the Panero brothers of Delano, August and Er-

My mates and I used to compete to see who could pour soft drinks from the greatest number of 12-ounce bottles, lining up the cups and pouring all at once. I think my record was six, no doubt with some

They earned their spending money in the potato fields and sheds. That was back in the stone age, when jobs were assigned by gender.

My starting wage was 65 cents an hour, and I quit work at the Sprouse-Reitz dime store in November to take the better-paying job at the theater. The dear little couple who ran that store could pay me only 50 cents an hour, and it was seasonal work. That's when I got my Social Security card and memorized the number immediately. in to check seats and be sure everything was ready, and I remember projectionist Max Pearce broadcasting lovely recorded music on the sound system -- classics like Duke Ellington's "Sophisticated Lady" and


"Mood Indigo" and "Satin Doll" -- and, alone on the carpeted space between seating areas, I'd dance the length of it, inspired by the music and wishing I could dance like Ginger Rogers. It was Max's job, in the little booth high up above the loge

section, to load

two projectors with their strong beams of light, being sure to get them in the right order and tend them throughout the movies. When the film broke and left the screen black, he'd soon know it by the shouting, clapping and whistling that came from the audience. A few minutes later the problem would have been resolved and the rowdy crowd would settle down as the movie resumed.

Some parents dropped their children off on Saturdays for the double feature and didn't return to collect them until a couple of cycles had passed, expecting us to babysit them for hours. And we did. At that time patrons could enter at any point in a film and no one thought that odd -- if you missed the beginning of the calculate how much their adult plus children's tickets would cost, take the cash and make proper change -- there were no automatic ways to do that back then, it was all head work -- so after a few nervous attempts, I left that job to cooler heads, like Bonnie Bender's. She loved being out there in the glass box, meeting the public first. I wish I could recall the prices of tickets, and whether Bonnie made more money than I did because of her superior position.

Some of my other work mates were Betty Taylor, Doris Gilwitz, Syble Nelms and Mariann Devlin, while Barbara Stone, Norma Neuman and others staffed the newer State Theater (built about 1944) on James Street, capacity 550. The manager there was a nice ter 9 p.m. Small town stuff -- fewer restrictions, lots of trust and no fear. And Bonnie, my school savior, said she wanted to work at the Shafter Theater, which was near her house, but her mom didn't want her out late on school nights, so she managed to get a daytime job as a soda jerk at the fountain in McClure's Drugstore on Central Avenue, and she remembers the heavy work of making ice cream in large machines there. "At McClure's, we made soft and hard ice cream. At the end of the counter there was a little glassed-in room with the two large machines where the ice cream was made. We hand packed many cartons of hard ice cream for customers. The hardest days were when we had a runon



nie, were the cinema kings of the Central Valley. They owned movie theaters from north to south in Sanger, Wasco, Shafter, Delano and McFarland. Hollywood reigned then as the film capital of the world, and the Paneros helped bring the pictures produced there to our rural areas. The two Shafter theaters

were open weekday evenings and weekends. Saturday matinees included films starring actors like John Wayne, Roy Rogers and Tex Ritter, with Gene Autry and Lash LaRue in cliff-hanger serials. Technicolor was improving and the musicals were beautiful, featuring Fred Astaire and Ginger Rogers, Cyd Charisse, Betty Hutton, Gene Kelly, Bob Hope and Bing Crosby and many more stars. Movietone News brought us black and white coverage of the events of our country and the world, and there were always cartoons on the movie bills that have now become classics -- Bugs Bunny, Donald Duck, Daffy Duck, Tom and Jerry and Woody

tertainment. With World War II behind us and agriculture booming in the valley, every-

thing seemed

bright and hopeful. And the young girls who were fortunate enough to be hired on to staff the theaters knew what choice jobs they had, compared to much less glamorous work in the potato sheds and fields.

I came to town as a ju-

nior at Shafter High School in the summer of 1948 and didn't know a soul on campus that first day, except for my freshman brother, Jerry. That was pretty terrifying for me until an empathetic senior named Bonnie Williams took me under her wing in Mr. Arnold's steno class and made me feel welcome. My acquaintance with her allowed me to ease into school life as we walked up Central Avenue daily for a while, and I'll always be grateful to her for that. We are friends to this day. And I soon got to know other girls who remain my friends sixty-seven years later. Coming from Visalia, a beautiful city, I wasn't so sure at first that my folks had done me a favor bringing me to this dusty little town full of chinaberry trees instead of oaks, but time has proven they did and now I can't imagine calling anywhere else home. In 1949 when I

and I became a Shafter girl



though not quite as good as modern stadium seating allows today. Teenagers usually chose to sit in those sections with their dates.

In later years, the rear of the building was gutted of all seating and floor levels and, with its lofty, echoey interior, served as a tire shop for Clyde Armstrong and then Bob Sperling (as well as an adjacent auto repair shop operated by Norval and Carol Winters), while the front housed the beauty salon of Jo Armstrong. Smart & Final did business out of the building for a time, too.

When the structure was demolished in 2000 to make way for the Rite Aid drugstore, I went to watch the work one day, though I was saddened to see it go.

I don't remember the Paneros advertising for their help, but perhaps they did in the beginning. All it seemed to take among the schoolgirls was knowing others who worked at the theaters, being willing to fill in for them when they wanted time off, and eventually, being hired on permanently as positions opened up. That's how I began in late 1948, learning from Syble Nelms and Betty Taylor, who paid me from their own earnings, how to work



The game was even better for the Generals' defense, who shut the Broncos out and didn't allow them into the red zone, dominating the line of scrimmage and stopping




came up short 12-8.
