## Vasquez enters race for county supervisor

In the heart of Kern County, Veronica Vasquez, a lifelong resident of Delano, is hoping to make history as the first Latina supervisor for District 4, including Wasco and Shafter..

Rooted deeply in the United Farm Workers movement, she comes from five generations of family advocates supporting farm work and labor rights.

Professionally, she has been an employee of the Department of Human Services working in Child Protective Services. "I

have been a social worker since 2007 in emergency response for the communities including Delano, McFarland, Wasco, Shafter, Lost Hills, Buttonwillow and the Bakersfield ZIP codes 93312 and 93314."

Vasquez has served two terms as Service Employee International Union Local 521 union president. "In this capacity, I was responsible for representing the employees whether it came to negotiations, worker's rights [or] lobbying elected officials to provide us with resources."

Currently, she serves as a Delano coun-

cilwoman. "My first two years, I was mayor pro tem. This experience has given me insight regarding budgets and providing necessary services to the community."

She thinks she is the best candidate. "I'm the only candidate that has been a county employee and the only one to advocate for the county employees first-hand, working side by side with them with many different agencies throughout the county."

Her upbringing has impacted her values for wanting to help the community.

"I come from a humble beginning, and as a social worker, I still live that way.

## Inmates say food spiked at Wasco prison

Prisoners at the Wasco State Prison are charging that razor blades, laxatives – and even rat feces – are appearing in their food, and prison officials are denying the problem and not helping the inmates.

Jakiya Abrams, who lives in northern California, said her husband, Sonny Gra-

nados, an inmate at the prison, called her to tell her of the incidents.

"It was their turn to eat. He is in Pod C, and as he was eating, he found a razor in his hot dog. Also, it was unknown that they were putting laxatives in their food until everyone was rushing to the bathroom," she said.

"They reported it to the officers, but the officers told them to be quiet and go to their pod, letting them know if they complained about it, they would come and raid

their pod or send them to solitary." Abrams said Sonny Granados called

her on Oct. 21 to share the complaints. "He got in touch with me today [Oct. 24] with an update. And he let me know

what was happening and told me they

me that one prisoner swallowed a razor and was bleeding. They refused him medical attention for two days."

were refusing toilet paper to them. He told

She said Granados had given her the phone numbers of different prisoner family members so they could also make complaints.

"The prisoners are afraid to call us directly because the phone calls get cut off.



## Parents guilty of abusing 6-week-old son

A Kern County jury found Jorge Millan and Elizabeth Jara guilty of numerous counts of abuse that nearly caused the death of their 6-week-old son.

On Oct. 19, Millan was found guilty of attempted murder, torture and child abuse under circumstances likely to produce great bodily injury or death. Jara also was found guilty of assault likely to cause great bodily injury and child abuse under circumstances likely to produce great bodily injury or death.

For more than a month - from March 20, 2021, to May 3, 2021, Millan and Jara confined the child to a room within their residence in Wasco, which was found in deplorable conditions, with dog feces and cockroaches throughout, In the case presented by Deputy District Attorney Janae

Knallay, during this period, under their care, the child suffered multiple injuries, including fractures of both sides of the jaw, a fractured collar bone, a spine fracture, 32 rib fractures, a broken femur, a fractured right arm, a broken shin and corner fractures on nearly all the long bones in his body.

Medical examinations indicated that these fractures were at various stages of healing, implying that they occurred on multiple occasions. Furthermore, the child had burns, bruises, a lacerated tongue, a torn frenulum and signs of blunt force trauma. The abuse came to light when Jara took

the baby to an urgent care facility, prompting the medical staff to contact law enforcement and an ambulance due to the child's dire condition. Subsequently, the child was admitted to Valley Children's Hospital, where he remained in critical



condition and required intubation in the intensive care unit for two weeks.

The attending physician testified that the child could have died without timely administration of life-saving medical treat-Text messages and pictures on Jara's

phone suggested her awareness of the abuse but her failure to act to put a stop to it. Additionally, there is proof of her involvement in concealing the crimes by notifying Millan about law enforcement's approach. She further attempted to hide the child's injuries by applying a Band-Aid to his eye and sneaking him through their bedroom window to prevent other household members from seeing his wounds.

District Attorney Cynthia Zimmer commented, "Although I'm glad the lifelong abuse is over, it breaks my heart to witness yet another tragic incident involving a child in our county. It is a miracle that the victim is still alive today, and atrocious individuals who threaten the life of a child deserve to be prosecuted to the fullest extent of the law."

The sentencing hearing is scheduled for Friday, Nov. 17, at the Kern County Superior Court. Millan is facing life imprisonment, along with an extra 5 years and 8 months. Jara may potentially receive a sentence of up to 13 years.

According to Museum Director Ronald Pierce, the project was a success and the facility has a bright new look to it.

We are thankful for this gift and we are very proud of our museum and its staff for all of their hard work on this project." The assistance came from the Charles

The work began in late August, with the preparation taking a considerable amount of time, removing six to eight layers of paint that had accumulated over the years. They also filled in cracks, replaced broken boards and sealed or replaced broken glass in the windows.

From Page 1 During our conversation today [with Granados], the phone call was disconnected,"

Prison officials say they are investigating the allegations. Terri Hardy, a spokeswoman for the the California Department of Corrections and Rehabilitation issued a statement Wednesday afternoon:

'CDCR's top priority is ensuring the health and safety of the people who live and work in our institutions. Wasco State Prison continues to follow all food handling protocols, which includes having sworn peace officers oversee the process. We are actively investigating these reports and as such we cannot provide further comment at this time."

Granados said her husband told her that officers inside the prison have rejected the charges, too.

"A sergeant reached out to me today [Wednesday] and made it seem like it was nothing, saying they have samples of the

food and supervise how the food is prepared as if it couldn't get tampered with. He said he has people watching over the inmates preparing the food."

She said she is deeply concerned for her husband's safety because the Wasco prison is currently being investigated for a couple of murders that happened earlier this year.

In a call with Granados, he said, "The other day, everyone had massive diarrhea, and I found a razor blade in my hot dog for lunch. Other prisoners were also finding blades. One of the prisoners got an x-ray, and they found a razor."

The medical team said they thought he did it to himself. Everyone is afraid to say anything because the officers told us that if we make a big deal, they'll start to take away our privileges."

He added that he saw prisoners from the dorm next door who found wires, razor blades and rat feces in their food.

"He hasn't eaten the food in four days,"

Abrams said.

"Officer Hernandez told us to just look through the food and be careful instead of giving us a substitute like packaged lunches," Granados said.

He said that another prisoner, Jesse Ramirez, found blood in his feces. "They waited a couple of days for him to be seen by medical. They took him and said not to worry about it but took it seriously when they took an X-ray and found the razor."

A relative of Ramirez, who lives in Riverside and wishes to remain anonymous, said, "It's not right what they are doing. They need to be more careful with their food. It's dangerous; a prisoner could die.'

'I spoke with him today, and he said he has been vomiting blood and is waiting for them to do something to take it [razor] out. They said he did it to himself. He's afraid to eat and hasn't eaten."

Abrams said she has tried to reach out to Warden Heather Shirley, "But she is

going around me and instead has had the sergeant call me who told me they are looking into it. I've called the receptionist, who told me they were in a meeting talking about it. I called the warden again, but it goes straight to voicemail, and her voice-

mail is full, and I can't leave a message." She added, "The prisoners are scared because they don't want to get beat up or

sent to solitary." Granados' sister, Lucy Granados, said the prisoners are being refused more toilet paper and have to use their bedding or

clothes in the bathroom. "He was supposed to have called me an

hour ago but never called." Lucy, who lives in Chico, said she reached out to the state inspector general's office. "I left them a message. It's a hotline; you have to leave your information, and they will get back to you. I'm still waiting. They said if there was immediate danger to call 911, but I don't know how that would work because I live in Chico."







Alexander Solzhenitsyn takes the unusual tack of telling us about a good day in the gulag - a Russian prison. It's a very effective device for showing how horrible life



in the gulag was, because a great day there was miserable. At the same time, it shows

that even in the gulag there are some interruptions to suffering. At the same time that we have many

blessings, we also have many challenges. That is normal. Paul could write that a great and effective door was opened for him. Ministry opportunities abounded, and there was a wonderful response. In the same breath he added, "and there are many adversaries." (1 Corinthians Where there are open doors, there are

also adversaries. Trials always accompany blessings in this life. Ultimately, for those who love the Lord, the blessings will prevail. We're helped through trials by the blessings. The trials are temporary, whereas the real blessings are eternal. And the trials serve a valuable purpose, in the purification of our faith (1 Peter 1:7). That doesn't make trials easy or insig-

nificant. Some seasons of life, some situations we pass through, are unspeakably hard. I'm not pretending that life is easy! In this life, our experience is always mixed. There's something good, and there's something hard. We never want to think in a pleasant

season that everything will always be easy. That's setting ourselves up to be disappointed the moment the going gets tough. On the other hand, the trials, hardships and adversaries should never make us lose sight of the blessings.

The Wasco Tigers kept their SSL title hopes alive with a 26-21 victory over the Taft Wild-**WASCO** 


Friday night. The win gives the Tigers a chance to share the title with a win over Shafter in the annual rivalry game this Fri-
