Mayor Givens sees a city 'where everything grows'

Shafter has been and is a city "where everything grows," Mayor Chad Givens emphasized in his State of the City address at the Chamber of Commerce Awards Saturday night.

"Over 100 years ago, people found this land, and realized that this was land where everything would grow," Givens started his address to nearly 200 in the Ford Theater. "Today, the city is still that. Shafter is the city where everything grows."

Givens was not just talking about crops, or the population,

but also the financial status, the economy and the physical dimensions. He commented on the many projects that are scheduled for this year, including the completion of the renovation of the Shafter Aquatic Center and many projects involving the city's parks. Add to that a new skate park and a new community park in North Shafter.

"We have made such progress on the economic side, with the creation of the Wonderful Industrial Park, the fiber optic lines that attracted big businesses, as well as building a model

The evening at the Ford Theater began with a State of the City address by Shafter Mayor Chad Givens (see separate story)


Before the regular awards, a special award was given to the late Helen Gaede, which was accepted for the family by Shafter Depot

Burnett will ride in the parade and will be there for the festivities at Mannel Park after the parade.

The longtime law enforcement leader began her career with the Police Department in 1992, eager to make a difference in a city that was growing and had a vision in which public safety was a top priority. Burnett would go on to become the highest ranking female officer in the department's history, being named assistant chief over two years ago.

Burnett said that she was continuous-

ly humbled by the accolades that were bestowed upon her, being an award for arrests, or recognition for her trail-blazing career that has opened up so many opportunities for women in the department. Burnett said that she was just taking advantage of opportunities made available to her because of women before her that had the courage to break those barriers.

Burnett was promoted to senior officer in 1996 and to sergeant just two years later in 1998. She kept moving up through the ranks and became a lieutenant in 2014.

Later, as a captain, Burnett also volunteered to represent the department with

City approves donor support

The City Council approved taking current donations of \$3,350 from local vendors, donors and Wonderful Company grants and future donations for the Wasco Police Department, and other city departments and projects.

"From time to time, companies and residents generously donate to city operations, and as such, staff will provide a report of donors and request authorization to accept the funds and increase appropriations," City Manager Scott Hurlbert said in a report to the council.

So far, in fiscal year 2023/2024 (July – January), the city has received donations of \$2,350 for the Police Department and \$1,000 for the Animal Control Depart-

"Staff recommends accepting these funds to use for the new Wasco Police Department and animal shelter projects. Staff will provide a quarterly update of future donations as they occur," Hurlbert

Also, at the meeting, there was a badge pinning for Police Department dispatchers Jessica Anguiano, Marylynn Ortega, Priscila Ruiz and Ivanna Russell.

"It's a momentous evening," Police Chief Charles Fivecoat said after the meeting, "We are fully staffed for our communications center, and I am very proud that all of our staff has faith in us to come here and help build the Wasco Police Depart-

Beware of kidnapping scam, police warn

A kidnapping scam is targeting local people, Sergeant Herbert Stout from the Kern County Sheriff's Office told the City Council Tuesday night. "It involves telephone calls to

residents in which the caller states that they have kidnapped a family member and demands money," Stout said. "They would then tell the person they are talking to to wire them money through a green dot card or a wire transfer through a local store. After transferring the money, they would hang up on them.'

Sergeant Stout recommends residents to immediately hang up on the caller, go check up on the family member, and then call law enforcement.

"Do not fall for the scam," he said. "And contact law enforcement at 661-861-3110. We just want to get the word out so people don't become victims."

Council OKs \$1.5M for new General Plan

The city will spend up to \$1.5 million for a new General Plan.

The City Council approved a contract with Place Works, Inc., to create the updated document.

The agreement includes making a vision for the city for the next 20 years. This will include economic, business, retail expansion and education plans. The process is expected to take about two years to com-

The council also discussed regulations regarding the use of artificial intelligence in the city. This includes sophisticated software that can improve the efficiency of administrative operations, including day to day work, as well as special projects, according to presenter David Franz,

He said that this software also can come with risks, such as being subject to hackers that attack certain programs. Franz said that for this reason, it would be prudent to create firewalls to protect the systems.

City Manager Gabriel Gonzalez said that there would be guidelines for city staff when utilizing the software, such as to not use information that may be subject to copyright laws. In other action, the council approved

a six-month extension on a development agreement between the city and the Seventh Standard Ranch Investors and Lennar Homes. It was brought to the council that the current agreement expires soon and an extension would ensure that a development agreement would be completed before this new deadline.

PASTOR'S CORNER Inheritance

Receiving an inheritance was a big deal in the Old Testament. People set their hearts on entering into their inheritance, and were serious about maintaining that inheritance and passing it on to their own

They had a great reason for that. God had promised to give them an inheritance, which we often call "the Promised Land." We call it that just because God had prom-

God enacted special legislation to preserve that land as an inheritance. For instance, in order to prevent land passing from one tribe to another, God told the Israelites that when daughters inherited property they had to marry somebody from their same That would tribe. keep land within the borders of the tribe.

But one of the tribes of Israel did not receive a land inheritance: the tribe of Levi. Instead of having farmland or forest, they got 48 cities with a little bit of land around

them. This meant that they could do some amount of subsistence farming, but bigger operations were closed to them.

God had a good reason for that. The



ent kind. Numbers 18:20 says: "Then the LORD said to Aaron: "You shall have no inheritance in their land, nor shall you have any portion among them; I am your portion and your inheritance among the children of Israel.'

Levites had an in-

heritance of a differ-

That meant that their lives would not

be like everyone else's (Numbers 18:23-24). It includes that the Levites received the tithes from the other tribes to meet their needs (Numbers 18:21). As others were given the work of cultivating the land, they were given the work of offering sacrifice (Joshua 13:14), and therefore they ate part of the animal sacrifices made to the Lord (Deuteronomy 18:1).

The distinct lifestyle, the receiving of contributions, and the special work to do were all parts of the main thought. "But to the tribe of Levi Moses had given no inheritance; the LORD God of Israel was their inheritance, as He had said to them. (Joshua 13:33). The Levites had something that more than made up for all they missed out on, in the special closeness they had to God Himself. For our own day it remains true
