# A special event for students

Due to the virus pandemic and the governor's order of a state lockdown, Wasco High School graduate Ruth Loza Ramos came up with the idea to Adopt a Senior.

"I did this because it's the last year of high school for graduating seniors," Ramos said. "They are missing important milestone events during their senior year such as in-person classroom experiences, senior prom, sporting events, field trips, visits to college campuses and other social events that occur at the school and within the community. I wanted to do something to make this year special for them, so I created Adopt a Senior so members of the community could be a part of the senior-year experience."

Friends, parents and relatives, as well as other community members, have been supportive of this project, and several students have received more than one adoption request.

As of Tuesday, Wasco has had 36 cases of COVID-19, with 26 recoveries. In Shafter, there have been 34 confirmed cases with 30 of those reported as recovered.

No one here has died of the virus, according to the county Department of Public Health's website dashboard.

There were 632 confirmed cases in the county, with 234 recovered and 22 are hospitalized in the county.

On the Kern County Public Health dashboard, Wasco

(ZIP code 93280) has had 36 test positive for the virus and 26 have recovered with no deaths reported in the city.

Gov. Gavin Newsom said that 53 out of 58 counties are eligible to enter into Phase II, which requires counties to have hospitalization rates that don't increase more than 5% over seven days and

have less than 25 COVID-19 cases per 100,000 residents

The county Board of Supervisors voted to certify its readiness at Tuesday's meeting. The county will now send a request to the state.

In Shafter, the City Council announced that they will be doing a test run next Wednesday at the Shafter Police Department Conference Room as it attempts to begin having in-person City Council meetings again. This procedure would mean that the council members, the city clerk and city attorney would meet in the conference room together to hold their meeting, while practicing social distancing required. According to City Manager Gabriel Gonzales, "This would be a great alternative. The public would still be able to view the meeting on the Zoom app, but the coun-

# Council tables study on pay

The Shafter City Council voted unanimously to table a compensation study that would determine what other comparable cities pay the

employees in their different departments, such as Public Works.

Recommended by City Manager Gabriel Gonzales, the study would be performed by Koff & Associates, a consulting firm that specializes in such studies. It would help with classification of different positions, as well as determining what the market value of those positions are, Gonzalez said.

The project would have a cost of approximately \$30,000, which would be funded by monies in the various depart-



and shoulder, doctors ran blood work. Tomas and Nicolas had not even made it home before they received a call to come back to the hospital immediately. The diagnosis was given, and Garza was

transported to Valley Childrens Hospital in Madera. "It was so weird. It was just a few pains. You never think it would be something like this," Garza said.

# SPD in Wasco

# Shots fired near home

On Sunday at approximately 9:30 p.m., deputies from the Wasco substation responded to shots fired at the 1200 block of 8th Place. During the investigation, deputies

learned that Espiridon Beltran, 40, had possibly fired several shots from a firearm in front of a residence. Additional investigation revealed Beltran was a restrained person in a criminal protective order protecting the victim who lived in a nearby residence, the Kern County Sheriff's Office said. Deputies located Beltran in the area

and detained him without incident. He

was in possession of a loaded firearm determined to be stolen. Beltran was arrested and booked into the Central Receiving Facility for carrying a loaded firearm, possession of a firearm by a prohibited person, violation of a restraining order and prohibited person in possession of ammunition.

"We don't know that the suspect that was arrested fired his gun," Sergeant Peter Martinez said. "We just know that the person arrested had an order from the court not to be near someone else and was in possession of a gun he could not legally possess." Prohibited by the court protection

order, the suspect was found in possession of a firearm. Because the gun was loaded with additional ammunition he is being considered a "prohibited person in possession of ammunition." "We did not charge the suspect ar-

rested for the unlawful discharge of a firearm," he said. "If we had probable cause for him firing the gun, we would have charged him with that, too."

In other business, the council reviewed an updated lease agreement with the Recreation and Parks District. This item was tabled until after the new Recreation and Parks District board can review it.



Caltrans said that if the fivelegged roundabout was considered, there would be a need for signals in all directions to ensure that vehicles trying to exit the at-grade Beech Avenue crossing are not held up by cross traffic.

Caltrans and Public Works both agreed that traffic signalization defeats the purpose of having a roundabout, which is to alleviate the traffic congestion and impacts of the BNSF Railway. It was also pointed out that when the High Speed Rail project has completed its section in the area, it would mean the elimination of Beech Avenue anyway. After discussion, the council

decided to approve the four-legged intersection without the Beech Avenue connection. This allows the studies and engineering plans to move forward.
