HSR, Package #4 to be completed by 2022

The High Speed Rail Zoom meeting on Thursday, August 26 provided some answers to questions that have been in the minds of many.

The HSR plan to continue building a subway to access the Amtrak platform, and construction further south of Poplar Avenue, is two to three years away.

The completed package is expected to be done with Package Number Four in late summer 2022. Also, the HSR will not start the Highway 46 crossing until Poso Street is finished.

Package Number Four does not include laying any rail, as that will take place at a later time.

They reported Kimberlina was open and plans have not changed to stop anywhere between Merced and Bakersfield. The HSR

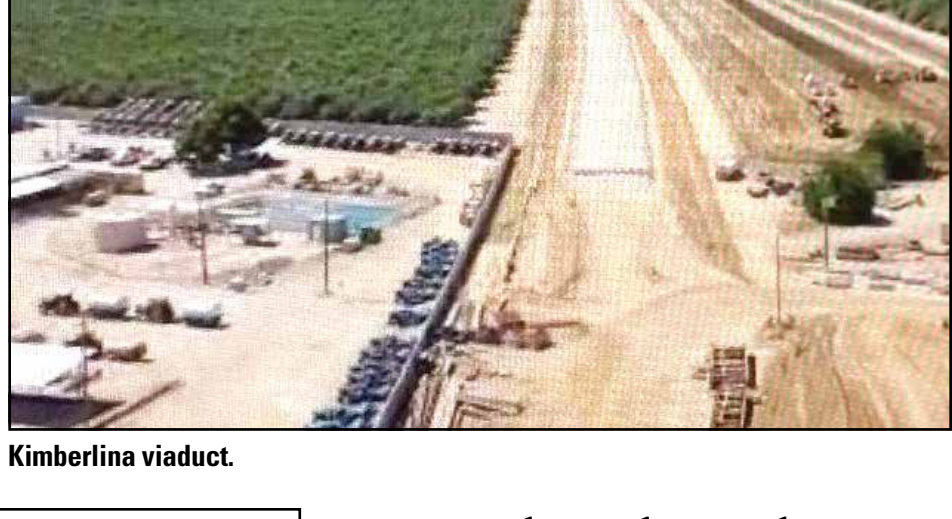

will only stop in Bakersfield, Hanford and Fresno. There will not be a stop in Wasco.

An anonymous attendee asked, "Why isn't there a stop between Bakersfield and Merced? It means in the future that anyone living between Merced and Bakersfield will have to travel to catch an Amtrak train at an inconvenience."

Because the question was not answered directly, an email was sent to Toni Tinoco and Gina Torres at the HSR.

Public Information Officer II Augie G. Blancas responded in an email to the question, "The Wasco Amtrak system is still in-service and open for travelers to purchase tickets via Amtrak's website and continue to board the train at the Wasco Amtrak platform," he wrote. "The high-speed rail will be operating on its own electrified tracks, separate from Amtrak's system."

The Shafter High Generals dropped their matchup with the

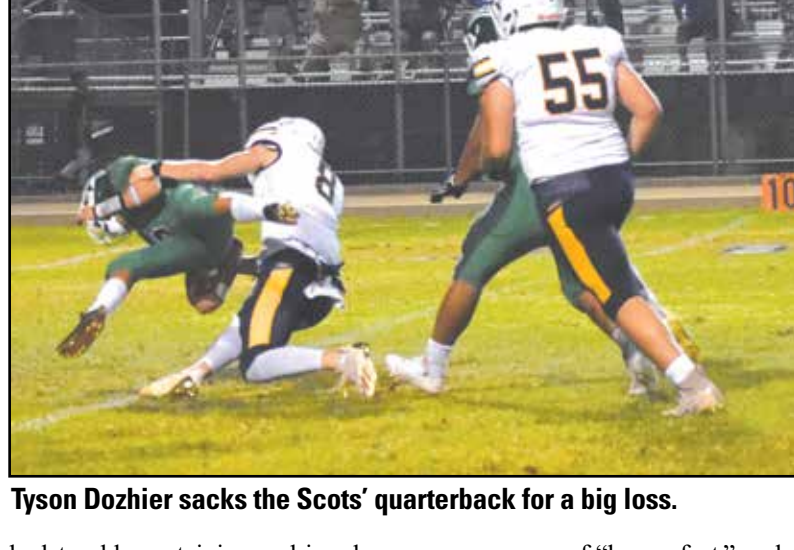

Friday night, 20-13. For the second straight week, the Generals failed to capitalize on scoring opportunities in the first half, coming away with only one score, trailing at halftime 12-6. The challenge was made even harder in the second half, when quarterback Tyson Dozhier was injured as he was playing on defense, suffering a broken collarbone.

Shafter started quickly on their first drive of the game, marching down the field on runs from Elijah Lucero and Dozhier, culminating in a 4-yard score by Lucero. Highland answered back with a long pass play, giving them a first and goal at Shafter's 8-yard-line. The Scots scored to tie the game up.

After that first drive, Shafter

had trouble sustaining a drive, being hurt by penalties and mistakes. The backs and receivers missed some key blocking assignments and Dozhier's timing was off and he had

a severe case of "happy feet," making it impossible for him to stay in the pocket and find open receivers.

Garcia had a dream to meet his heroes and see where they do that important job. Garcia's great-grandmother, Bule Rea, contacted the Shafter substation of the Kern County Fire Department to see if they could make his dream come true.

Rea said, "We made an appointment and they said that as long as there was not an emergency, they would be happy to show Elardio around the station."

Bule said that Elardio, who is 5 years old, was diagnosed with autism.

Rea said school officials recommended they enroll Elardio in a special needs school or program, but they decided to enroll him in a regular public school.

"We decided that we wanted to raise him and treat him as normally as we can. If he attends a regular school then he will have a chance to have as normal life as possible," Rea said. "He is doing really well in school and has made

Several Shafter High students recently received the highest honor bestowed upon students in the FFA organization. The American FFA Degree is awarded to students who have shown the utmost dedication to the organization through their desire to develop their potential for premier leadership, personal growth and career success through agricultural education.

Each recipient must first have been awarded the State FFA Degree from their home state, which are given out by each state's Future Farmers of America organization at their annual State conventions.

Infected continues to rise

The Kern County Public Health announced there are 511 newly reported confirmed cases in Kern County, bringing the total confirmed cases to date to 124,943. Also, there were three new deaths reported on Tuesday, August 31.

On August 31, the number of reported cases in Wasco was 4,711, a drop from the week of August 19, which were 5,725.

The number of infected in Shafter for August 31 was 3,123 compared to 3,870 on August 19. This is a decrease of 737 cases in one week's time.

Public Information Officer Michelle Corson said the 14-day case rate is 38.69 per 100,000 and as of August 29 725,313 doses of the covid-19 vaccine have been administered to Kern County residents.

As of 2019, the population in Kern County was 900,202, and 345,678 or 45.8% of Kern's eligible population has been fully vaccinated against covid-19.

As of August 30, Kern County had 270 covid-19-related hospitalizations and 51 were in the ICU.

In the most recent three weeks there has

been a 32.5% increase in first doses of the covid-19 vaccines administered in Kern County.

"We are encouraged to see first dose vaccination administration rates continuing to rise in our community," said Brynn Carrigan, director of Kern County Public Health. "We continue to urge everyone to use all available tools to protect against covid-19, including getting vaccinated, masking, physical distancing, washing your hands, staying home when you are sick or been exposed, and staying in overall good health by eating well and regularly exercising."

Due to the significant increase in co-

vid-19 cases and hospitalizations, the Santa Clara County Health Officer said the Delta variant is more transmissible than prior variants and may cause severe illness and even fully vaccinated individuals can spread the virus to others.

Because of this variant and the increase in infection rates, the U.S. Center for Disease Control and California Department now both recommend that all persons, regardless of vaccination status, wear face coverings indoors.

According to the Department of Public Health, the use of indoor face covering is the least disruptive and most immediately impactful additional measure to take.

"I know they have an important job and are very busy. I think that it is so special for them to take time out to brighten a child's world," Rea said.

In addition to firefighting, Garcia is enthusiastic about horses and took part in the

room after a year of distance learning, children are excited to be back in touch with their fellow students, getting to participate in classes, as well as the process of providing food for their meals. The menu at the Grow Café, which provides the breakfast, lunch and supper for the students, is filled with healthy meals that contain a good amount of produce that is grown on site at their Edible Garden, which is maintained by staff and the students, who work together to care for the plants and harvest them. They also have Meatless Mondays, where the meals are vegetarian, and the menu also contains a special day each week that highlights a teacher. The teacher gives the staff a family recipe that his or her family enjoys, and the meal is replicated for the school menu for that day. An Edible Schoolyard (ESY) is a garden classroom and kitchen classroom that provides a hands-on learning experience for

students. Students are able to get their hands in the soil, cultivate, plant, water and harvest their own produce. The produce is taken to the kitchen classroom, where students use real tools to create a delicious meal. Students then set a beautiful table, share conversation and eat together. They encourage students to explore and awaken their senses to the world around them, and to appreciate food through seed to table education. The ESY is a space that brings the academic classroom to life. Students are not only able to connect their experiences in the garden and kitchen to content they are learning in the classroom, but are also developing and practicing vital life skills, teamwork and learning how to nourish themselves in all areas of life. As the Grow Academy of Shafter begins its first year taking eighth graders, the school is growing just as the edible garden is, thriving and giving the community of Shafter and its youth a healthy and positive place to grow.

More about the U.S. Capitol Christmas Tree

Most people are familiar with the lighting of the national Christmas tree near the White House. During the ceremony the

President flips a switch that lights the tree. But few people are aware that down the street on the West Lawn of the U.S. Capitol is another magnificent tree traditionally lit by the Speaker of the House of the U. S. House of Representatives.

For 51 years the tree has been presented to us as a gift from one of our national forests. Thousands of handmade ornaments are created by the citizens of the state from which the tree was donated. For this, and other reasons, the tree is called The People's Tree.

The 2021 tree will be coming from Six Rivers National Forest in California. The theme of the project is "Six Rivers, Many People, One Tree"

The search for just the right tree took several months and covered hundreds of acres and thousands of feet in elevation. The tree selected, nicknamed Sugar Bear,

is an 84-foot white fir from the Mad River Ranger District. The search and selection was done virtually using drone footage to locate the majestic tree that will represent the Six Rivers National Forest and the state of California.

The People's Tree comes from a district that was ravaged by the largest recorded wildfire in the history of California – the August 2020 Complex Fire. Nearly 160,000 acres, a little over 50% of the district, was destroyed by the fire.

The tree, therefore, is a significant choice because it represents the fortitude and resilience of the community. The tree project also brings joy and hope to the district as it begins its journey to Washington D.C.

The tree will be harvested in late October and travel around the state of California and cross-country before arriving in Washington D.C. In late November, after the lighting ceremony the tree will remain on display for a month during the holiday season for thousands of citizens and visitors to Washington D. C. to enjoy.
