Romero named Richland superintendent

The Richland School District has named interim Superintendent Rosa Romero as the district’s permanent superintendent, signing a three-year contract. Romero had been the interim superintendent since late 2019, after the resignation of Dago Garcia. She is facing a school year that has begun with distance learning, which has been a requirement for districts in counties on the state’s watch list.

Recently Governor Newsom announced that schools will be allowed to open the school site for a limited number of students, with an emphasis on allowing special education students to return, as those students have the greatest need for in-person learning.

Romero said the interview and selection process was a long one, but that it didn’t involve any other candidates, with the district focusing its attention on securing Romero for the position.

“I think that I am a really good fit for

the position, with my years of experience here in Shafter, and the relationship I have with the existing administration and the teachers,” she said.

Romero said the biggest challenge facing the district is the importance of giving children a quality education in this difficult time. “It is challenging, but we are dedicated to giving our kids a quality education, be it from a distance or in person,” she said.

Romero and her staff had had a plan in place that involved allowing students to return to school for the fall semester. Newsom’s announcement forced the district to switch to distance learning. The district then created a program that has the children able to do independent work throughout the day, while different groups read or do work with the teacher. The teacher is online all day, available for any problems that the

Romero said the district is creating a new vision in Shafter which includes giving the children an education that will make them ready for high school, college, the workforce, and a global economy that is changing daily.

Shafter High School graduate to be a Marine Corps MP

Lance Corporal Nathan Gonzalez graduated from the Marine Corps Military Police Academy at Marcordet Fort Leonard Wood, Missouri, on August 18, 2020.

Gonzalez received the Distinguished Honor Graduate by finishing at the top of his class with an average of 97.86 throughout his training. He received letters of commendation and was meritoriously promoted to lance corporal.

Gonzalez is a 2019 Shafter High School graduate and is the son of Mike Gonzalez of Shafter and Tiffany Tatum-Knox of Wasco. He entered the Marine Corps in November of 2019 and graduated basic training with top shot or Company High Rifle Expert in January.

Gonzalez will be stationed in Okinawa while begin-

“I joined the Marines to follow in my father’s footsteps and it has turned out to be one of the best experiences of my life,” Gonzalez said. “I have gained rapport with many new people from around the U.S. and I have been taught how to implement my job properly by some of the best instructors the Marine Corps has to offer.”

Gonzalez was originally supposed to attend a K-9 Handlers Course at Lackland Air Force Base in San Antonio, Texas after he completed the Police Academy but that course is not operating at this time. Gonzalez intends to pursue the job as a K-9 handler by completing on the job training while in Okinawa.

Council rescinds agreement to close 6th St.

The city has been negotiating with the High Speed Rail for almost 10 years and while the city has made several concessions, the HSR hasn’t been as forthcoming with the city, City Manager Daniel Ortiz-Hernandez said at a meeting before the Sept. 1, 2020 City Council meeting.

Ortiz-Hernandez presented a staff report that stated on April 18, 2017, the HSR asked the city to modify the HSR’s plans that were presented on Dec. 6, 2016 and

the discussion was about the closure of 6th Street and the 6th Street railroad crossing where a plan was approved outlining the new construction of underpasses at both railroad crossings for 6th and Poso Avenue.

“Because it has been more than three years since the city approved the closing of 6th Street, the HSR has failed to provide a written agreement outlining the specific terms and con-

ditions, including the detailed plans for its closure,” Ortiz-Hernandez said. “If they

plan on building from Bakersfield to Los Angeles, the HSR will have to come up with additional monies.”

Another issue is that once the HSR is up and running, the Wasco Amtrak train will no longer be available, which means that residents will have to drive to Bakersfield to catch Am-

trak, causing additional pollution, gas consumption and more vehicles on the road, which is the opposite of what the HSR indicated in their earlier presentations that the goal of the HSR is to lessen the pollution in the San Joaquin Valley.

The HSR has put on several showcases in Wasco outlining the benefits of having the train run through Wasco; however, since it won’t stop in Wasco, the city won’t benefit from it, but the HSR impacts the city of Wasco in several negative ways such as having to relocate the farm labor camp because the tracks were too close to the for-

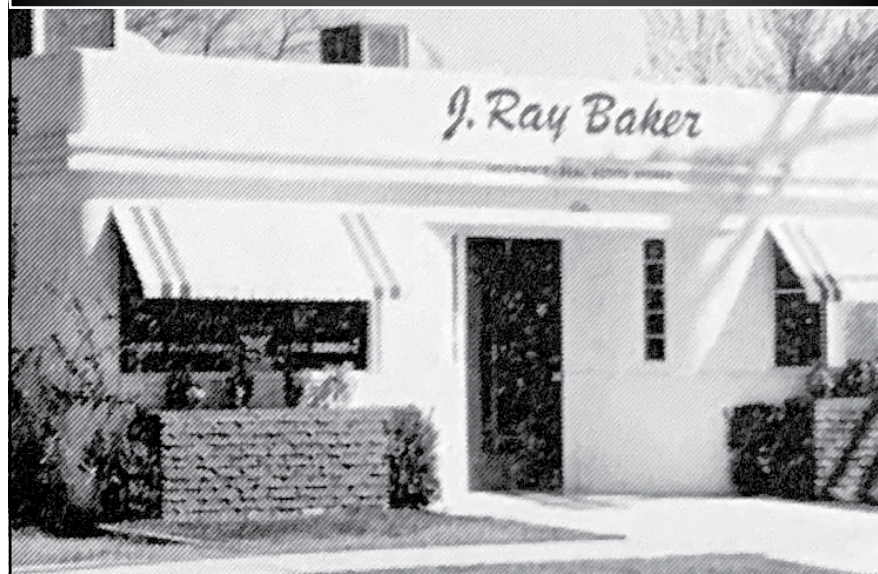

Local man's uphill battle with covid-19

After experiencing a week of continual coughing and lying delusional on the floor, on Aug. 3, Fernando Alaniz was taken by ambulance to Mercy Southwest for breathing problems.

Alaniz had been experiencing a week of feeling sick and progressively worsening with a cough that wouldn't quit. He was tested for covid-19 and the doctors discovered his blood sugar was very high.

He was told he had diabetes and was close to being in a diabetic coma, which could have happened at any moment. Alaniz was immediately started on an IV. At the same time, his test also came back positive. With the diabetes and his underlying condition of asthma, this was not a good sign.

After being diagnosed, he was in the ER for almost a week until they had to

they had to do extensive blood cultures. "The doctors were searching for what caused the sepsis alert," sister-in-law Cathleen Gotsch said.

As of Aug. 30, Alaniz's oxygen level was at 96%. He also continues to receive strong antibiotics and around 40 liters of oxygen. "His oxygen level needs to be down to 4 to 5 liters in order to be transferred to the long-term care facility to begin rehab and therapy," Gotsch said. "He continues to receive lung X-Rays which monitor the bilateral covid pneumonia he is fighting."

Alaniz will have to relearn how to swallow due to damage to his trachea and vocal chords from the intubation. "As of Aug. 27, he is still unable to talk, but his blood sugar is normal," Gotsch said.

She said his coloring is

ceiving assistance through the CARES Act and through benefits from their employers, both are teachers and those benefits will come to an end before all of his therapy and recovery are complete.

Because of Fernando's illness, Christine has not been able to return to work and wants to meet her virtual class and get her school year started in order to teach her students. But with all of his daily medical decisions, updates and insurance coordination, she is not able to prioritize teaching at this time.

Fernando also has a long road to recovery ahead of him. His wife isn't sure of the time frame when she will be able to support her students' needs as their daily teacher.

Alaniz is from Guadalajara, Mexico and immigrated to Wasco with his mother and family when he was 5 years old. His family made Wasco their home and he attended Karl Clemens Elementary School, Thomas Jefferson and Wasco High, graduating in 1991.

He attended Bakersfield College for a year and then in 1992 he was recruited to play football at McPherson College in McPherson, Kansas, where he met his wife,

Alaniz returned to California to continue his degree. In 1996 Fernando and Christine married and had their first child, Sara.

He took a pause in his education to take a job as a student affairs specialist at Delano High School. He was there for two years and then was hired by the Kern County Sheriff's Office in the technology department. He and Christine had two more children, Samantha, and Fernando.

Alaniz finished his degree in Criminal Justice Pre-Law but was really passionate about computers and about teaching. He left his job at the Sheriff's Office and started to substitute teach while completing his master's degree in computer science engineering.

In 2019, he finally made his dream of teaching technology a reality by teaching technology at McFarland High School. He was hired

last year and was ready to start teaching computer science and dual enrollment for keyboarding and career choices during the 2020-2021 school year at McFarland High.

Alaniz was in his last two courses at Walden University online and was slated to graduate in December. But then, covid-19 struck, so those plans are on hold for a long while.

He is a devoted husband and father and is passionate about his family and teaching technology. "All who know him know he is an extremely kindhearted man of unwavering faith who would give you his shirt off his back," Gotsch said.

Since March, Alaniz and his family have attended online Sunday church together and as a family, they pray together. "Prayer has been a part of Fernando and Christine's entire marriage and they have made

it a daily priority," Gotsch said. "The life and family Fernando and Christine have built mean the world to them both."

Their daughter Sara has "left the nest" and is currently out on her own. Daughter Samantha is living at home and has entered the workforce. Youngest son Fernando recently started his senior year online at Wasco High School online.

The family asks for any support to relieve the financial burden of Fernando's recovery and rehabilitation to allow him and Christine to focus their time and energy on restoration of health and security of their family.

A GoFundMe page has been set up by Gotsch in order to support both their medical and rehabilitation costs over and above what will be covered by insurance and is set up to provide general household assistance.

make room for him in the Intensive Care Unit.

While he was in the ICU the week of Aug. 10, he was put on a ventilator because his lungs were not able to function on their own. He remained in the ICU until his oxygen levels were more stable. During the week of August 17, the breathing tube was taken out.

While this was going on, chest X-rays were taken several times a day as his lungs showed fluid in them. On Aug. 23, Alaniz was moved to a new unit in the hospital called telemetry, where he is still being cared for.

In this unit, he is monitored around the clock for any changes. At one time, there was a sepsis alert so

returning, and the nurse who has been working with him waves to his wife during his FaceTime sessions with his wife, Christine, and children. "He is able to follow very simple commands and respond with head nods, but still has a long ways to go," she added.

Gotsch also said he should be able to be moved to a long-term health facility in several weeks where he will begin physical, respiratory and speech therapy.

Alaniz has a very long road to recovery considering he is still in the telemetry unit. The beginning of his journey to recovery is still unknown.

While the Alaniz's are insured and currently re-

Council opposes wider use of force disclosure

The City Council has approved a letter opposing widening the scope of what peace officer personnel records can be disclosed.

The letter, which will be sent to the state Sen. Nancy Skinner, argues against Senate Bill 776. In it, the council states the measure is excessive in the types of personnel records it makes subject to disclosure and is overly punitive when it comes to the fines imposed for violations.

Currently, records of incidents involving any use of force by a peace officer are to be disclosed only if there were sufficient findings that the officer was not within department guidelines.

The proposed bill would open any records of reports of force to be disclosed, even if it were determined that the officer was exonerated.

According to the council's letter, "the release of officer records for incidents involving any use of force, especially those in which

the officer is entirely within departmental policy, can lead to misperceptions about an officer's conduct, resulting in flared tensions between law enforcement and community

members instead of effective dialogue."

Fines for records not being disclosed are proposed at up to \$1,000 per day for each day beyond 30 days that records are not dis-

closed. The council stated that it would cost extra to handle an increase in the amount of requests for records including increased staff hours and in additional training.

Also at its meeting, the council approved a tract map that will bring new residential development to East Tulare Avenues and North Reiker Street. There are 10 lots on the parcel, with each consisting of about 11,000 to 12,000 square feet. There is no plan yet for what the price range will be for the homes.

Developer Vernon Gunter, of Bakersfield, requested the tentative tract map. According to the Planning Commission's Wayne Clausen, the members of the City Council will have input on the size and use of the tract.

Council members had an opportunity to ask questions about the tentative map. Council member Manuel Garcia commented that he hopes this development is different than more recent developments, which have stalled.

"I hope and pray that Mr. Gunter has the means to follow through on this project. The city of Shafter really needs more homes available," said Garcia.

As you enter F & R Auto Repair and GF Tire Center, you are surrounded by autos and parts, but still warmly greeted by whoever is working closest to the entrances.

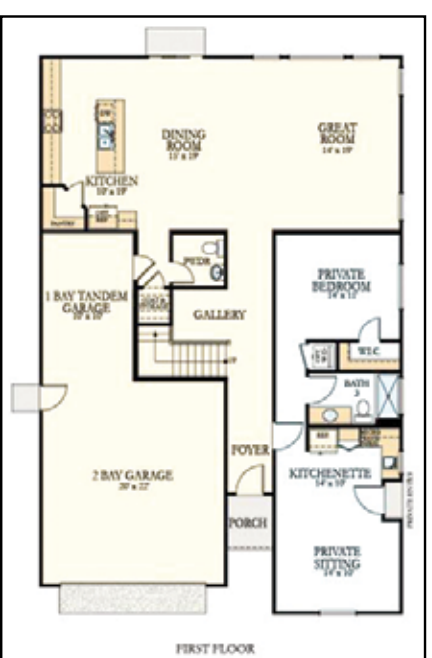

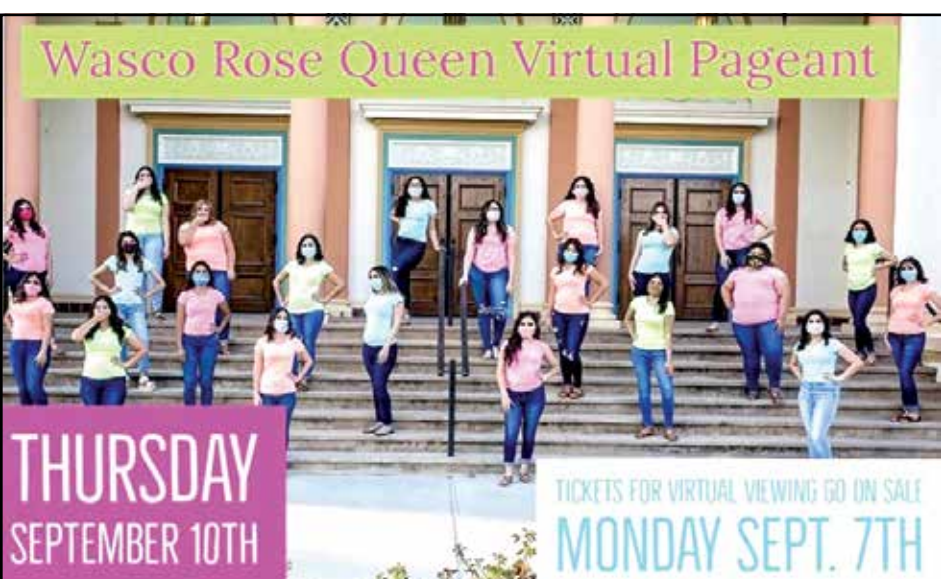

shops for indoor service, provided they follow the Center for Disease Control and Health Department's previous guidelines utilizing masks for all employees and clientele. In addition, the businesses must continue with the sanitization practices as outlined earlier in the governor's directive.

Because of the intense heat in Kern County, this comes as welcome news to hairdressers in Wasco.

Hairdressers Luz Santania and Juana Quintanilla from Diva's Hair Salon on 7th Street said that while business has been slower, they are expecting more of their regulars to return soon.

Restaurants can continue to remain open and serve outdoor dining, take-out and delivery, while gyms and fitness centers must remain closed.

"We are still just take-out," said El Pueblo Restaurant's Jasmine Casilla.

A shop filled with collectibles had not officially opened Monday, but owner Paul Barraga from Botanica Luna Nueva on 7th Street said he anticipates opening later in the week.

In addition, shopping centers may be opened with limited indoor operations. This means limiting the number of people allowed inside a store at one time, and limiting the number of diners inside a food court.

COUCH'S CORNER

You bring the ideas, we'll try to implement them

One of the great things about being your county supervisor is the chance it gives me to hear your ideas and help implement them, when feasible. Three current examples of this come to mind, which I will share with you here. We can't always implement these ideas, and I won't promise you something I can't deliver, but the door to my office is always open, and your ideas are always important to me, even if sometimes for one reason or the other, we can't make them happen.

One recent idea we were able to make happen, which has been written about in this column recently, is the mobile field-testing clinic for covid-19 that we implemented a few weeks ago with the farm workers of District 4.

The California Farmworkers Foundation, along with Good Samaritan Hospital, both came to my office with their idea to do field-testing, and in a short time, our of-

fice was able to help them get a contract using CARES Act funding to do this in Kern County.

Another recent example of an idea coming to fruition is a new rental assistance program coming to Kern County to help prevent evictions and reduce homelessness that might be brought about by the economic fallout from the pandemic.

Folks from Faith in the Valley and the Leadership Council, two organizations active in helping the underserved community, wanted to make sure we understood their concern that many folks affected by covid-19 might be facing eviction soon. They came to us (through Zoom) to share their concerns about the pandemic's effect on people being able to pay their monthly housing payment. When covid-19 first hit, a moratorium on evictions was established that protected our community from the

disastrous effects of all those thrown into unemployment not being able to pay rent. That would have led to a greater homelessness crisis, so a 6-month moratorium was established that ends September 1.

Faith in the Valley and the Leadership Council wanted to make sure that, with September fast approaching, we were ready to prevent evictions that might follow, and in anticipation of those concerns, our Board of Supervisors approved an agenda item this past Tuesday establishing new guidelines to protect those that truly need help with their rent.

Similarly, a group called "Building Healthy Communities," which is a coalition of groups in Kern County dedicated to representing the poor and underserved segments of our population, contacted my office a couple of weeks ago to ask our help in implementing a plan they have that would increase contract tracing for the Latino community.

We brought in Matt Constantine and the entire Public Health Department into the discussion to find covid-19-response shortfalls and look for ways this group could help the county better educate and protect this population. After two good group discussions, we've identified some things that might truly help improve awareness and are taking next steps to make this happen.

It's all about listening, and cooperation, and the community knowing that the door is always open to our office, even if it's just a virtual door these days for you to share your ideas and help us make this a better, safer place to live. This is the way I believe democracy is supposed to work, where we, the people, work together and where all our ideas are welcome.

PARCEL NUMBERING SYSTEM
EXPLANATION

A parcel numbering system is a numerical system for referring to each parcel or property within Kern County. The standard parcel numbering system consists of, first, the map book number; secondly, the page number within the map book, and block number if one exists; and the parcel number within the block. By this system a county is divided into geographical areas called map books, each map book into geographical areas called pages, each page into blocks, and each block into parcels as owned and used. mer camp and having to permanently close 6th Street at Poso. But the HSR is leaving Wasco without a means to travel Amtrak.
According to Ortiz-Hernandez, the HSR told him that it isn't cost effective for the HSR to stop in Wasco.
Ortiz-Hernandez said the project is adversely affecting Wasco.
Mayor Tilo Cortez and Council member

Alex Garcia were both absent from the Sept. 1 meeting; however, the council voted 3-1 to rescind the cooperative agreement because the HSR isn't being cooperative with the city.
The city will keep 6th Street open to through traffic until the parties execute a written agreement.
"The closing of 6th Street will provide the HSR with significant cost savings," Ortiz-Hernandez said.

Ortiz-Hernandez also said that the HSR has not commented on his press release regarding the negative impact the HSR has had on Wasco.
In other business, the council unanimously authorized the purchase of two all-electric vehicles and three hybrid vehicles using California's statewide contract for fleet vehicles using the San Joaquin Valley Unified Air Pollution Control District Public Benefit Grant

Program not to exceed \$146,000.
The council also agreed to move the selection of delegates to the League of California Cities annual conference to the next council meeting when a full council is present. Mayor Pro Tem Danny Espitia and Council member Gilberto Reyna both said if the meeting is virtual, they would both attend; however, if it is in person, they would not.

PASTORS CORNER

A daily dose of Proverbs is a good idea

"If you faint in the day of adversity, Your strength is small." Proverbs 24:10
Don't you just cringe when you read some of Solomon's pithy yet profound nuggets of truth in the Wisdom book of Proverbs? Yet, this is exactly why it is so important for believers to read a bit of Proverbs every day. ... They are written for the purpose of giving one wisdom and instructions for the everyday ups and downs of life.
In light of Solomon's "prickly" truth for today, allow me to ask a question: What do you do when the prospects of success turn into the dust of discouragement? Or when the moonlight and roses suddenly morph into "diapers and dishes?" Or perhaps the robust and healthy life you have always experienced takes a turn in the other direction and you find yourself facing a time of pills, pain and powerlessness?
The first reaction for most is to ask, "Why

me Lord?" However, would not the more pertinent question be, "Why not me, Lord?" If the believer's life was always on the up-tick, and one always got a big scoop of ice cream on his or her pie then the whole world would be lining up to join the "club." But the truth of the matter is it is when our neighbors, friends, co-workers and enemies see us walk through the dredges of life with a good attitude and a peace that passes all understanding that they see the true Christ of Scriptures.
Viktor Frankl, a 20th century Austrian psychologist, a Jewish survivor of the Holocaust, gives a wonderful insight into the matter when he wrote; "Everything can be taken from a

man but one thing: the last of human freedoms – to choose one's attitude in any given set of circumstances..." He also wrote, "When we are no longer able to change the situation – we are challenged to change ourselves..."
Good advice but how do we achieve this lofty goal? Glad you asked. I believe the answer is in a little formula the Great Apostle Paul gives us in Philippians 3. First and foremost, Paul's life was not one of constant success nor of "peaches and cream" at every turn, was it? As a matter of fact, when he gives this formula he is in a Roman jail awaiting execution. Yet he pens a very important and succinct map on how to view

every situation of life with faith and peace.
Philippians 3:13,14 reads, "(13) Brethren, I do not count myself to have apprehended; but one thing I do, forgetting those things which are behind and reaching forward to those things which are ahead, (14) I press toward the goal for the prize of the upward call of God in Christ Jesus." Here is Paul's formula in facing adverse circumstances:
1. Forget the Past (you cannot change it)
2. Focus on the Future (therein lies the power)
3. Forge ahead in the Present (do what you can when you can with all the gusto you can)
Now, the decision is ours...do we want to wallow in the past's muck and mire or by the power of Christ that dwells in you, press on knowing that the word promises "I can do all things through Christ who strengthens me!" Phi. 4:13
