# Crackdown on fireworks

The Shafter City Council held a special meeting this week to assist the Police Department in their fight against violators of illegal fireworks ordinances.

On Thursday, June 25, the council voted unanimously to approve a resolution that would cost those citizens who shoot off or have possession of illegal fireworks \$1,000.

City Attorney Marco Martinez addressed the council and said that there are different ways that violators can be pursued. "There is the criminal route, in which the Police Department presents the District Attorney's Office with a report and the violator is charged with different code violations," he said. "There is also a civil avenue that can be lengthier and can result in monetary penalties for violations."

The proposed resolution presented to the council would give the police the authority to issue violators a \$1,000 fine. The violator would have seven days to pay the fine. The fine can be the result of the person or

persons lighting off illegal fireworks, being in possession of illegal fireworks, or owning the property on which the fireworks are being shot off.

Martinez said the problem this year has escalated from previous years and is still getting worse. He also said the problem is difficult to enforce.

In years past, those people who have even been found using or possessing illegal fireworks faced a fine of only \$50, which did not serve as a deterrent. According to Police Chief Kevin Zimmermann, the danger of illegal fireworks is not just the threat of injury, but there is also a risk of

property damage, including the chance of a burning ember landing on a roof or a field. "It is also dangerous for residents' pets and their owners as they try to deal with the on-going problem."

Zimmermann added, "We are hopeful that with the real risk of facing a sizable

## Reform WHS attacks harassment at WHS

Harassment, no matter what kind, often leads to serious consequences.

Students at Wasco High School (WHS) who are a part of Reform WHS are getting the word out that they demand to be heard and listened to by the powers that be.

About 25 students were in front of the high school auditorium with signs declaring their intent to be heard and that action must be taken against anyone who bullies or verbally or sexually harasses students. The complaint is that they are tired of any type of harassment that occurs on campus by anyone and want something done about it besides just talking and being told to stay away from each other. The students are demanding that changes be made to protect them and future generations of students

from these types of situations.

The protest on Thursday, June 24, was a peaceful one with students prepared for a long, hot afternoon by bringing plenty of water and snacks for participants.

They insist they are not out to damage property or assault anyone, but just want the district to hear what they have to say and make some needed changes.

One of their demands is that the district hire professional mental health therapists instead of using school counselors, who are not trained to treat mental health issues.

They also want the school to reprimand those accused and charged with harassment and to quit telling the victim and perpetrator to stay away from each other.

# With 31 positives, PrimeX shuts down

PrimeX, a local grower, producer and international trader, has shut down until July 3 after 31 employees tested positive for the Covid-19 virus. A worker first tested positive for the virus on June 10.

After picketers protested outside the company's facility on Wildwood on June 25 demanding free protective masks, gloves and more information from the company, all workers were sent home that day.

On Thursday, a message on the PrimeX website said, "PrimeX office and warehouse will be closed Monday, June 29, through Friday, July 3, to allow 9our employees time with their families."

PrimeX owns and farms over 5,000 acres of pistachio orchards in California.

The number of 31 infected employees "is correct," PrimeX's chief operating officer, Mojgan Amin, said in an email Sunday evening. "Since March, we have been checking the temperature of all the employees starting their shift. We require them to

follow Center for Disease Control and Prevention quarantine guidelines before they are allowed to come back to work."

Amin denied in the email that workers at the company had gone on strike. "A few days ago, around ten of our employees were practicing their right to have their voices heard. We have listened and will continue to listen to their voices."

Amin added that the company has already been providing face coverings, gloves, sanitation supplies and training on how to prevent the spread of COVID-19, as well as disinfecting materials. She also said PrimeX has been communicating with all their employees since early March. "This is not a new practice," she said.

"Again, no strike has taken place," Amin said. "Not a single employee walked out nor participated in a work stoppage and no one has definitely participated in a strike."

In addition to the pistachio orchards, PrimeX markets nuts (pistachios and cashews as well as dried fruit, such as raisins.

PrimeX became the first Pistachio farm to go solar and prides itself on maintaining a "green" environment.

Amin said the following steps will be taken:

■ A professional 27-person team wearing HazMat suits will

be rolling out the Anti-Covid-19 spreading protocols.

■ Among other methods and techniques for deep cleaning and sanitation, this team will be using a process known as Liquid Atomization. This process is used to sanitize

the area, previously cleaned equipment and environment that liquid sanitation solutions alone cannot reach.

■ Once the sanitation has been completed, the company will be using a process known as ATP Bacterial Testing (Adenosine TriPhosphate), which measures the metabolic activity of a molecule to identify the presence of any remaining microbes.

■ Once the ATP testing is completed and PrimeX can meet the state and federal guidelines and food safety certification, Safety Food Quality Level 3 (SFQ) levels, which are the highest standards for food quality and safety, the company will then be one critical step away from re-opening the plant.

■ The company will also have a mobile FDA-approved rapid Covid-19 testing unit set up in the facility to test every employee.

"Employees who test negative will be allowed to start working in our facility that will be completely sanitized and free of SARS-CoV-2 (Covid-19)," Amin said. "Employees who test positive will be required to follow the CDC quarantine guidelines."

# Shelter resumes rescues

One group of the population that has been hit hard with the current pandemic is the animal residents of the county, with its shelters limiting their services, including suspending all adoptions and rescues.

In March, all adoptions and rescues were suspended. Last week, however, Shafter's shelter reopened to the public, with all services in operation, including adoptions. There are guidelines to follow: All business is by appointment only, and face coverings are required to enter the shelter building.

During the past three months, the Animal Control Department has been hard at work, responding to calls of stray or injured animals, as well as emergency calls. "We were not allowing any adoptions but we were kept busy maintaining the facility, caring for the animals, and making sure that everything would be ready once it was safe to reopen," said Nick Riddick, animal control officer for the city of Shafter.

Since the reopening, the shelter has enjoyed a brisk business with several adoptions and a number of rescues.

"Since we reopened, within the last week and a half, we have had over 100 animals rescued and sent with our different rescue partners, giving so many animals a chance at a great home." Among those finding a new home is Roxie. Roxie was adopted by Luis and Alma Aguirre. Aguirre said that their little girls picked out Roxie and they recently took her home after her spaying

surgery. "Nick and the staff were great and we are so happy with our Roxie. Our girls love her and we now have a great new addition to our family!"

Riddick said they are still encouraging residents to call and take care of business that can be handled over the phone, or that can be resolved with the department responding to a call rather than the resident having to come to the shelter. "We don't want to have to have people waiting outside, especially in the heat, when something can be taken care of with a phone call," he said.

With the issue of illegal fireworks in the news, Riddick said it is especially a challenging time for the pet population. "With an increase in the use of illegal fireworks, it poses not only a threat to personal injury and safety, it also puts our four-legged friends in deep distress. Dogs are sensitive to sound, and when frightened by the loud booms, they sometimes flee from their safe home environments into the public streets."

While loose, according to Riddick, they are a danger to themselves and others, particularly when hit by cars causing their injury.

"This makes it even more important for people to report those people who are lighting those fireworks. Reporting violators can keep all of our members of the community safe, even the little furry ones."

Employees paid for the chance to hit members of management in the face with whipped cream pies. Three of the managers took turns getting pies in the face, with Ade Silesia leading the dollar total by a huge amount. The good sport took more than five pies in the face for a good cause. Also getting a big helping of pie was the facility's general manager, Ignacio Villa. Joining in the fun was Aaron Mealy. Employees took their turns planting whipped cream in their faces. The facility, when open, will mean 300 jobs for local residents, with the majority of them STEM-related in nature.

# A possible return to staying at home

With the governor of California reinstating the

## SHAFTER

Stay at Home order for one county in the state, 12 more counties have been put on a watch list, creating the possibility that the order may be reinstated. To try to negate the need for it, an order has been made that makes it necessary for residents to wear a face covering whenever entering most public buildings in the state. In Shafter, more than 75 percent of businesses now require customers to wear a face mask to enter.

Even businesses that didn't have such an order in place while the Stay at Home order was in effect are now requiring a face covering. Dollar General and Family Dollar, both considered essential businesses that were allowed to stay open through the entire Stay at Home order, are now making sure that customers wear face masks.

On a recent visit, a woman pushing a stroller with a child in it was not able to enter the Dollar General because she didn't have a face mask. A fellow resident saw

this and gave the woman a mask to wear, allowing her to do her shopping. After Governor Newsom opened the state back up, allowing more businesses to reopen, California was quickly hit with an increase of Covid-19 cases. Kern County was one of the counties with the highest increases in cases, making leaders consider the possibility that the reopening may have been premature.

The new requirement, cumbersome to some residents, still has not hurt local businesses. Angel Saavera of the Family Dollar said, "We require all customers to wear a mask now, but it has not hurt our business. People have been real understanding about it."

Dania Gomez of the Dollar General said, "We have had a few people getting really angry about having to wear the masks, but we have to abide by the order. Business has been good even

through the order, with most of the customers having patience with the requirement."

Another development is the closure of the state's bars, which includes Shafter's Foxy Lady. Newsom determined that bars

create an environment conducive to spreading the virus. This could be followed by the re-closure of other non-essential businesses.

For mask-free shopping,

you can still go to Apple Market in Shafter, which is not requiring customers to wear masks. They are practicing social distancing and the employees are wearing masks in the store.

"Practice begins July 6 and ends July 30," he said. "There are no swim meets this year, but we will be working with swimmers to improve their technique for the 2021 season, when (hopefully) we're able to get back to competitions."

He mentioned that only previous Tigersharks may attend this summer's practices because new swimmers need more one-on-one training and during this time, that does not allow for safe distancing.

Seeking activities where kids can burn off calories or energy, Wasco Recreation and Parks has been able to come through with numerous activities for kids in town.

"As we all are aware, guidelines and recommendations change every day, so this may change at any moment but as for now the pool will remain closed." Wasco Recreation and Parks District Manager Vickie Hight said.

She reminded everyone that playgrounds, restrooms, courts, youth sports and workout equipment remain closed to meet the guidelines of the Kern County health officer.

The department is looking into screening movies in the park and will provide dates and times when they become available.

"The park walking paths are open, we all need fresh air and exercise and Wasco Parks walking paths are great for that," Hight said. "Remember if you are in the parks, please practice social distancing, wearing of masks and washing your hands when you return home. Parks make life better!"

Probably the hardest hit this year have been the schools. Superintendent of the Wasco Union Elementary School District (WUESD) Kelly Richers said that summer school was held for Migrant and Special Ed.

"Schedules varied, and are still ongoing," he said. "What is required in an IEP (Individual Education Plan), speech, other help, was offered individually or in small groups as per the individual education plan wherever we got caught up enough to do it."

Richers said the district is still struggling to cover everyone because sometimes many were not able to be contacted. "Migrant also had summer school," he said.

Richers also anticipates that school will start as stated previously on August 10; however, the district will be using social distancing, which means that only one-fourth of the school's total number of students will be attending school each day of the week. They will

be continuing with virtual classroom instruction the remainder of the week.

Richers also said staff is working on a final preparation plan for the opening of school and that information will be forthcoming. "Unless we are shut down completely," he said.

The animal shelter has been closed since March 17. They are currently not taking in any animals nor adopting any out.

Within the past week as the numbers have been rising, businesses have placed signs requesting masks for anyone who enters an establishment.

This is most noticeable in grocery stores where the wearing of a mask is not enforced; however, most shoppers are donning them.

Also, at the Knights of Columbus fireworks booth in the Tropicana shopping center, volunteers all had on masks and extra masks were available for customers as well as hand sanitizer for all who arrived without a mask or wanted to clean their hands. The volunteers all maintained their safe distance from the customers.

"Wasco Rotary has not been meeting due to going dark in the summer months," incoming President Brad Maberry said. "Additional information will be forthcoming."

# Students make a statement

Citlali Arrazate is the spokeswoman for the group. She was willing to share her story as to how she became a part of the group.

Arrazate originally attended Delano High School for her freshman year and was in the Wonderful Academy where she could not only earn her diploma but also an Associates degree at the same time. When she was told she could not participate in any other school activities, she decided she wanted out of the program because there were other things she wanted to do.

"I didn't want to continue in the program because I couldn't participate in any athletics at school," Arrazate said. "It was after I left Delano High that I attended Wasco High my

sophomore year."

She said that when she arrived at WHS, one of her male classmates began harassing her on her first day in class. He would follow her wherever she went. Then, he began touching her. "One time, he grabbed me around my waist and pressed me into his body," she said. "I told him I didn't want him touching me."

She also said that the boy took switches (tree branches) and hit the backs of her legs with them. "I didn't feel safe going to class anymore," Arrazate said.

Arrazate said the classmate would tell her he knew she wanted him, so why was she fighting it? He also told her he knew she liked him. She demanded that he stop bothering her. When she did that, he got mad at her and

she feared for her safety.

The harassment continued and Arrazate reported the incidents to the vice principal, Mr. Prado.

"The boy was told to stay away from me at school," Arrazate said. "But he continued to follow me and finally I just stopped going to school because I didn't feel safe." She also said that nothing happened to him. He remained in her classes.

"He was a track and field athlete," she said.

Arrazate said nothing else was done about the situation. "I began to get angry at my mom and argue with her because of how I felt about everything," she said. "I had so much anger in me."

Arrazate said her grades started slipping. "I started out with a 4.2 Grade Point Average and ended with a 0.2 when I left WHS,"

Arrazate said she met with Wasco Independent High School (WIHS) staff and told them about the problem. WIHS set her up with a counselor from Grizzly Academy. "The Academy was started by the National Guard," Arrazate said.

"I didn't go back to WIHS," she said. "Instead I finished high school at the Academy."

Arrazate described Grizzly Academy as a military-type school, which is located on a military base in San Luis Obispo. "It's part of the National Guard."

"I never thought about

going to a military school, Arrazate said. "But the discipline and structure were just what I needed, and I ended up loving it. I was able to graduate from high school early."

Grizzly Academy is a residential program and is funded by the National Guard, so her schooling there was free of charge.

Arrazate is now in living at home with her mother in Wasco. She spent the past year at Bakersfield College majoring in psychology.

She excitedly shared that she has enlisted in the Navy and will be leaving November 16 for the Great Lakes Naval Station in Illinois.

Arrazate described arriving at the Academy and said that the first two weeks were the toughest. "They try to break you out of your civilian lifestyle," she said. "We got 30-second showers."

She believes Grizzly Academy instilled in her a way to control her temper. "I used to just blow up at anything," she said. "I've learned how to get out of my shell."

She is looking forward to being in the military and can't wait to do some traveling. She will be doing anti-submarine work and search and rescue.

Arrazate arrived with her friend, WHS student Diana Flores, who is also a member of the Reform WHS group.

Flores was present to provide moral support for her friend.

Have you ever thought to yourself, "Why did God create me with stinky armpits?"

Maybe it's just me. But I have often wondered what purpose armpit odor has.

Before I give you my answer, let me tell you a short story that may give us some insight.

# Video results in community support and arrests

An arrest was made over the weekend and three other cases were handed to the District Attorney's Office for investigation regarding a rash of illegal fireworks activity in and around Shafter.

Police Chief Kevin Zimmermann posted a video reaching out to the community for assistance in catching the perpetrators, who have been inundating the community with a series of explosions, some strong enough to rattle windows. Shafter's pet population has

also been disturbed by the noise.

Zimmermann said he doesn't know the reason for the increase in illegal fireworks activity, but he said it has been a bad year already. "I don't know if it is from people being cooped up due to the quarantine or what, but this year has seen a big increase in the number of illegal fireworks being set off in town, and also the period of the activity is a lot longer."

Zimmermann said the best defense

against the activity is the involvement of the community. "The best-case scenario we have is if a resident sees the activity and knows either who is doing it, or the precise location of the activity," he said. "A lot of people don't want to go as far as a private citizen arrest, but even the precise location of the activity while it is going on can help us tremendously in catching the lawbreakers."

Zimmermann said it is not only the fireworks the police are dealing with this year, but also a number of acetylene bombs, which put off a very big explosion. "It is

not only the fact that our pets go crazy, or the noise and nuisance of the activity, but there is a real danger of physical harm with these illegal fireworks," he said. "I would hate to think what would happen if one of those landed on an older roof. It would be so dangerous."

Zimmermann thanked the community for their cooperation and continues to encourage the community to get involved. Residents with information about illegal fireworks are asked to contact the Shafter Police Department at 661-746-8500.

### PUBLIC NOTICE AN URGENCY ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SHAFTER, CALIFORNIA, AMENDING CERTAIN PORTIONS OF CHAPTER 1.12 OF THE SHAFTER MUNICIPAL CODE RELATING TO ADMINISTRATIVE CITATIONS AND FINES FOR VIOLA- TIONS OF THE CITY'S FIREWORKS REGULATIONS

NOTICE IS HEREBY GIVEN that on June 26, 2020, the Shafter City Council adopted Urgency Ordinance No. 718. The following is the official adopted ordinance:  
WHEREAS, the use of illegal fireworks has sparked fires throughout the City of Shafter ("City") and caused fire crews to respond to fires caused by illegal and dangerous fireworks; and WHEREAS, the use of illegal fireworks create a significant hazards to personal safety and property; and WHEREAS, the Police Department receives numerous calls related to the use of fireworks in the days leading up to and after the 4th of July holiday each year; and WHEREAS, the use of fireworks within the City is ongoing, and enforcement of these regulations has proven difficult; and WHEREAS, in order to address this serious public safety issue, City staff has sought ways to deter the possession and lighting of illegal fireworks in the City, including by increasing penalties; and WHEREAS, there is a need to amend the regulations to further deter the use of illegal fireworks within the City; and WHEREAS, the City Council has determined that the public health, safety, and welfare will be served by: (1) authorizing the Chief of Police or designees to issue administrative citations for illegal firework violations; (2) authorize the City Council to establish administrative fines by separate resolution; and (3) authorize the issuance of a citation to a property owner or person leasing or occupying property where an illegal firework is observed. THE CITY COUNCIL OF THE CITY OF SHAFTER DOES ORDAIN AS FOLLOWS:  
SECTION 1. Urgency Findings. In accordance with California Government Code, Section 36937 in order to protect the public health, safety and welfare, the City Council of the City of Shafter find as follows:  
A. The use of fireworks within the City is ongoing, and enforcement of these regulations has proven difficult. The use of illegal fireworks cause property damage and a danger to life. The Council, therefore, adopts this Urgency Ordinance to become effective immediately upon adoption pursuant to Shafter City Charter Section 4.12 and Government Code Section 36937 and to remain in effect until rescinded to provide City enforcement officials with a means to deter the use of illegal fireworks.  
B. In addition, the City wishes to have these new regulations in place for the 2020 Fourth of July celebration when access and use of illegal fireworks increases throughout the region. The City would like to further mitigate the use of illegal fireworks in order to protect the public peace, health, and safety of its residents.  
C. The City Council also finds that this Urgency Ordinance is necessary to promote the immediate preservation of the public peace, health and safety by establishing administrative fines for the possession or use of fireworks and their associated dangers within City's boundaries.  
D. Finally, the City Council finds that the regulation contained in this Ur-

gency Ordinance are reasonable in order to preserve the public peace, health and safety of its residence ahead of the Fourth of July holiday. SECTION 2. Section 1.12.020 of Title 1, Chapter 1.12 of the Shafter Municipal Code is hereby amended to read as follows:  
"Responsible person" means a natural person or legal entity, a natural person or legal entity who is the owner, tenant, cotenant, lessee, sublessee or other person with any right to possession of the property where a violation of city codes occurs that is related to the use of property; the owner, majority stockholders, corporate officers, trustees, and general partners of a legal entity; and the on-site manager who normally works daily at the site and is responsible for the activities at such premises. Responsible person also include the parent of legal guardian of a minor that commits a violation of this code."  
SECTION 3. Section 1.12.030 A.3. is hereby added to Title 1, Chapter 1.12 of the Shafter Municipal Code to read as follows:  
"Fireworks violations. Violations of Section 8.12.020 of this code shall subject a responsible person to an immediate citation and fine in an amount determined by separate resolution of the City Council. Fines for fireworks violations shall be due within seven (7) calendar days of the date of issuance of the administrative citation."  
SECTION 4. Section 1.12.050 A. of Title 1, Chapter 1.12 of the Shafter Municipal Code is hereby amended to read as follows:  
"A. All fines are due on the day of the administrative citation is issued or the date noted on the administrative citation except that fines imposed for substantive violations or nonemergency health and safety violations shall be due on the day following the expiration of the reasonable period of time granted to correct or otherwise remedy the violation or upon the expiration of any extension granted."  
SECTION 5. Section 8.12.060 is hereby added to Title 8, Chapter 8.12 of the Shafter Municipal Code to read as follows:  
"8.12.060 Enforcement. Penalties.  
(a) The Chief of Police or his or her designee, upon determining a violation of this Chapter, may issue an administrative citation, in accordance with Chapter 1.12, to the responsible party, person leasing or occupying the property or the property owner of where the firework was observed or discharged.  
(b) The City Council may establish an administrative fine for violations of this Chapter by separate resolution."  
SECTION 4. If any section, subsection, sentence, clause, phrase, or portion of this Urgency Ordinance is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have adopted this Ordinance, and each section, subsection, subdivision, sentence, clause, phrase or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrases or portions might subsequently be declared invalid or unconstitutional. SECTION 5. CEQA Determination. The City Council finds that this urgency ordinance is not subject to the requirements of the California Environmental Quality Act, pursuant to (Guidelines) Section 15060(c)(2) & (3) as there is no potential for physical changes to the environment as this ordinance implements administrative regulations only for the possession, sale and discharge of fireworks only. SECTION 6. Effective Date. This Urgency Ordinance was adopted by the necessary four-fifths vote of the members of the City Council pursuant to California Government Code Sections 36934 and 36937, and shall take effect immediately upon its adoption for the preservation of the public health, safety and welfare. SECTION 7. This urgency ordinance was adopted by 4/5 vote of the City Council. The City Clerk shall certify the adoption of this Ordinance and shall cause the same to be posted as required by law. Printed certified copies of Ordinance No. 718 are available for inspection by any person at the office of the Shafter City Clerk, City Hall, 336 Pacific Avenue, Shafter, California.
